### **Electorate Allowances**

For Members of the House of Representatives, electorate allowances are paid according to the size of the electorate represented, as follows:

(1) Less than 2000 sq. kms: \$32,000 per annum

(2) 2000 and less than 5000 sq. kms: \$38,000 per annum

(3) 5000 sq. kms. and over: \$46,000 per annum

For Senators the minimum amount of electorate allowance is paid. There is no linkage to the area represented.

### **Additional electorate allowance of \$19 500 per annum in lieu of private-plated vehicle**

Part 6 of Remuneration Tribunal Determination 2012/04 entitles parliamentarians to a private-plated vehicle to be used for parliamentary, electorate or official business. Senators and members make a personal contribution to the cost of the vehicles as specified in guidelines issued by the Special Minister of State. From 20 March 2006, senators and members who choose not to be provided with a vehicle "will be entitled to an additional \$19,500 per annum of electorate allowance in lieu of the private plated vehicle to meet the costs of transport within and for the service of the electorate".
