 - all parties to the nuclear Non-Proliferation Treaty, including Australia, have expressed their "deep concern at the catastrophic humanitarian consequences of any use of nuclear weapons",
 - (ii) nuclear weapons remain the only weapons of mass destruction not yet prohibited under international law in a comprehensive and universal manner, and 127 nations have pledged to fill this legal gap,
 - (iii) the United Nations (UN) open-ended working group on nuclear disarmament adopted its report on 19 August, which recommends that the UN General Assembly convene a conference in 2017 "to negotiate a legally binding instrument to prohibit nuclear weapons, leading towards their total elimination", and
 - (iv) the Australian Red Cross and the International Campaign to Abolish Nuclear Weapons have called for the adoption of a UN General Assembly resolution this year to convene negotiations in 2017 on a legally binding instrument to prohibit nuclear weapons; and
- (b) urges:
 - (i) the Australian Government to support all efforts in the First Committee of the UN General Assembly this October and November to establish a mandate for negotiations to commence in 2017 on a legally binding instrument to prohibit nuclear weapons, and
 - (ii) the Australian Government to participate constructively in negotiations on such an instrument.

 - (ii) a United Nations-backed tribunal ruled in July, in a case brought by the Philippines, that any extensive claims to the sea had no legal basis and that China's construction of artificial islands in disputed waters was illegal,
 - (iii) Beijing has reacted furiously, with foreign ministry spokesman, Lu Kang, implicitly threatening military action and a "decisive response" if anyone took "any provocative action against China's security interests based on the award",
 - (iv) China and Russia have recently staged war games in the South China Sea, in a show of force after an international tribunal invalidated the Chinese Communist Government's extensive claims in the area,
 - (v) Australian warships, planes and soldiers have begun annual joint military exercises with four strategic allies in the sensitive South China Sea region involving around 400 Australia ADF personnel,
 - (vi) those 400 Australian Defence and thousands of our allies military personnels' lives are now at serious risk from a hostile Communist Government threatening military action, while we exercise a right of freedom of navigation in international waters, and
 - (vii) according to research undertaken by the Department of the Parliamentary Library, the same Communist Government have been allowed to spend tens of billions of dollars and buy into major Australian infrastructure critical to our national security, including Port Melbourne, Darwin Port and Hydro Tasmania; and
- (b) taking into the above facts, a resolution be placed before the next joint sitting of Parliament which calls on the Australian Government to ban all sales of major Australian infrastructure to the Chinese Communist Government and its various associated investment companies while ever a military threat exists to Australian Defence Personnel who abide by international laws and United Nations Tribunals' rulings.

 - (i) 1 December is West Papuan National Flag Day, commemorating the day in 1961 when the New Guinea Council – West Papua's Parliament under Dutch colonial rule – raised the Morning Star flag for the first time, signalling the Netherlands' recognition of West Papua's statehood
 - (ii) since Indonesia formally annexed West Papua in 1969, West Papuans have been waiting for the opportunity to determine their own future, having been denied the right to selfdetermination.

- (iii) the human rights situation in West Papua continues to be deeply troubling, with 4 000 arrests of non-armed citizens in 2016 alone, and
- (iv) Indonesian Defence Minister, Mr Ryamizard Ryacudu, recently stated that Indonesia had asked Australia to urge our Pacific Island neighbours to withdraw support for West Papuan membership of the Melanesian Spearhead Group; and
- (b) urges the Australian Government to:
 - (i) encourage the Indonesian President, Mr Joko Widodo, to fulfil the commitments he has made in relation to West Papua since his election, including his commitment to releasing all political prisoners, and his promise to seek justice for the five young people shot dead on 8 December 2014 in the town of Enarotali while peacefully protesting,
 - (ii) call for the removal of untenable barriers to media access and academic research in West Papua, including lengthy waits for visas,
 - (iii) clarify that the recent improvement in bilateral relations between Australia and Indonesia is not predicated on Australian support for Indonesia's position on West Papua, including Australia's silence on human rights violations committed there, and
 - (iv) confirm that the Government has not agreed to encourage members of the Melanesian Spearhead Group, particularly current Chair Solomon Islands, to withdraw support for West Papuan membership of that Group.

- (a) acknowledges and congratulates the Honourable Justice Susan Mary Kiefel, AC on her appointment as the next Chief Justice of the High Court of Australia;

 - (B) vocally criticised the US judicial system when it blocked this ban in line with US and international law.
 - (C) threatened to send the American military into Mexico,
 - (D) accused Japan, China and Germany of currency manipulation,
 - (E) suggested that the US might once again have the opportunity to steal Iraq's oil,
 - (F) said that torture "absolutely" works, and
 - (G) ordered the Department of Homeland Security to issue a weekly list of crimes (allegedly) committed by undocumented immigrants in sanctuary cities, amongst many other alarming actions,
 - (ii) the Trump Presidency is causing deep concern and unease in the Australian community,
 - (iii) President Trump's discriminatory ban further unfairly demonises Muslim people, when there is not a shred of evidence that immigrants from the countries covered by the ban have killed people on US soil in a terrorist attack,
 - (iv) our Government's deal to transfer our refugees to the US is causing untold human suffering and trauma, particularly in light of the Trump administration's delays and prevarications, and
 - $(v) \quad \text{our alliance with the US is making our country less safe, not more safe; and} \\$

- (b) urges:
 - (i) the Australian Government to stand up for Australian values and hold President Trump to account, as leaders of other nations have done, and
 - (ii) the Australian Government to re-negotiate the terms of the US alliance and commit to an independent, non-aligned foreign policy, in the interests of a safer Australia.

 - ticket scalping and the use of software to bypass computer security systems to purchase large numbers of tickets has a detrimental impact on genuine fans who often miss out or have to pay hugely inflated prices for events,
 - (ii) while there is a benefit in having a secondary market place for consumers to on-sell tickets when they have a legitimate reason to do so, many consumers are not aware that they are buying from a secondary market site as the business practices of many of those sites have the potential to mislead or deceive consumers in relation to their purchase, resulting in consumers purchasing tickets that are not genuine or at a vastly inflated price,
 - (iii) consumers are generally not able to rely on statutory consumer protections when they purchase tickets from secondary market sites,
 - (iv) in December 2016, the United States Congress passed the Better Online Ticket Sales (BOTS) Act of 2016 which makes it illegal to use software to purchase tickets to popular events
 - (v) the United Kingdom Government is also considering measures that would criminalise the misuse of "bot" technology to unlawfully obtain tickets to events,
 - (vi) the United Kingdom's Consumer Rights Act requires that key details of tickets offered for resale should be given at the time of resale, including the face value of the ticket, seating area, as well as any restrictions that apply, but Australian consumers have no such protections.
 - (vii) the Senate Economics References Committee, in its report on ticket scalping in Australia tabled in the Senate in March 2014, identified the negative impact ticket scalping has on consumers, and
 - (viii) despite the findings of the Senate Economics References Committee, the Government has not made any substantive changes to address the issues identified in the report; and
- (b) calls on the Government to introduce legislation similar to the Better Online Ticket Sales (BOTS) Act of 2016 to better protect consumers from ticket scalpers.
