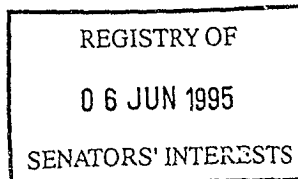



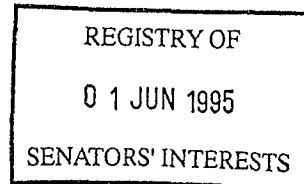

On May 6, 1995 I returned from a study tour of Turkey for the 80th Anniversary of Anzac and the 75th Anniversary of the formation of the Turkish parliament, and to Switzerland and the United Kingdom for interviews in connection with the Senate committee enquiring into certain overseas transfers of Australian soccer football players.
