I am writing to you in relation to Senator Rice's letter to Ms. Skinner, Chief Executive Officer, Services Australia, dated 11 February 2022.

Data Descriptions

Recipients of JobSeeker Payment who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system, and not in receipt of zero rate of payment.

Recipients of Youth Allowance (other) who are determined to be current (i.e. entitled to be paid) on the Centrelink payment system.

Duration on Income Support refers to the duration the recipient has spent on income support payments. Duration may not reflect duration on current payment type.

Partial Capacity to Work refers to activity tested recipients with an assessed work capacity of under 30 hours per week.

Principal Carer refers to recipients who have principal caring responsibilities for a dependent child under the age of 16.

Note: Indigenous recipients include only those who have voluntarily identified as indigenous. These data may therefore represent an undercount.

Note: Non-English speaking background describes persons born outside of Australia, in countries where English is not the main language spoken. This indicator should be used with caution as it is based on country of birth. Source: Services Australia administrative data, DSS extract.
