FURTHER INFORMATION REGARDING EVIDENCE PROVIDED AT SUPPLEMENTARY BUDGET ESTIMATES HEARING

Dear Mr Raine,

I refer to the appearance of ASIC officials before the Senate Economics Legislation Committee (**the Committee**) at the Supplementary Budget Estimates hearing on Thursday 16 February 2023.

The purpose of this letter is to seek to clarify and supplement the evidence I provided at the hearing, and to provide an answer to the question taken on notice requesting a copy of the letter from the Secretary to the Treasury to me about the conduct of Deputy Chair Chester.

At the hearing, I informed the Committee that I received correspondence from the Secretary to the Treasury in respect of allegations about the conduct of Deputy Chair Chester which were referred to Treasury for investigation.

Shortly following the hearing, and upon refreshing my memory regarding the matter by reviewing the letter from the Secretary to the Treasury, I identified a need to provide the Committee with additional clarifying information.

ASIC considers that as with all inquiries into matters concerning the conduct of ASIC officials, it is important that such inquiries are treated with sensitivity and confidentiality to protect the privacy of all individuals involved (including those that make disclosures and witnesses), and do not disclose sensitive information that unreasonably reflects adversely on individuals.

Having said that, in the interests of transparency and to clarify the information I provided to the Committee, I <u>enclose</u> the following letters which provide additional information about the outcome of the investigation into the conduct of Deputy Chair Chester:

- a) A letter from the Secretary to the Treasury to me dated 1 February 2022;
- b) A letter from me to the Secretary to the Treasury dated 28 February 2022;
- c) A letter from me to Deputy Chair Chester dated 28 February 2022; and
- d) A letter from the Secretary to the Treasury to Deputy Chair Chester dated 1 February 2022.

I am informed by Deputy Chair Chester that her evidence to the Committee is based on the information provided to her on the outcomes of the Treasury investigation, letters (c) and (d) above. Ms Chester has not had access to letters (a) and (b) and informed me that she has not had access to the report from the investigation.

Outcome of investigation into allegations made about the conduct of a Deputy Chairperson of the Australian Securities and Investments Commission

I refer to my letter to you dated 1 June 2021.

I have received a confidential and legally privileged report of an investigation into allegations that have been made about the conduct of Ms Karen Chester as the Deputy Chairperson of ASIC for the purpose of the Commonwealth obtaining legal advice.

The investigation found that many of the instances of alleged conduct could be wholly or partially substantiated as to the fact that specific things occurred, although in many cases recollections differed about the specific conduct and its substance and significance.

I have concluded, having had regard to the report and advice I have received, that there is an insufficient basis on which to advise the Treasurer to take any further formal steps in this matter relating to potential actions that may be taken under section 111 of the ASIC Act.

I consider that the investigation has revealed instances of conduct regarding the standards set out in the ASIC Code of Conduct.

On this basis I refer the matter to you for your consideration of next steps.
