#### **Question:**

Has there been an increase in the number of staff in total in the New Delhi mission, not just locally engaged staff?

#### Answer:

The COVID-19 consular response in India is a very high priority for the department. Despite an escalating pandemic across India, the High Commission in New Delhi has maintained staff levels and re-organised staff responsibilities to allow for strong focus on the consular response. The Consular and Crisis Management Division in Canberra has provided significant additional support to India Posts, including establishing a dedicated team to organise facilitated flights. Additional support has been provided by an AUSMAT team member deployed to New Delhi on 22 May 2021 (arriving 23 May), to provide expert public health support to assist pre-departure arrangements.

There has been no change to A-based staff numbers on long-term postings to New Delhi. There are a small number of staff preparing to undertake short-term missions or short-term assignments to New Delhi to fill established positions. There have been no additional locally engaged staff hired above normal staffing levels.

**Answer:** The Department of Foreign Affairs and Trade engages with a range of stakeholders, including around 20 engagements since 1 February with academia, civil society and the Myanmar diaspora, to support our policy development in response to the situation in Myanmar. These have included meetings with a range of Myanmar ethnic community groups.

#### Question:

In relation to foreign affairs staff overseas and COVID-19 vaccinations, how are we going? Are they all vaccinated?

### **Answer:**

The health and safety of staff is the highest priority for the department, including the rollout of vaccinations to all staff and dependants overseas.

DFAT and the Department of Defence are working together on a COVID-19 vaccine rollout for all Australian Government employees and their dependants who are currently deployed/posted, or about to deploy or be posted, overseas. The rollout commenced on 12 March 2021 and aims to offer a COVID-19 vaccine to all individuals in the overseas network by October 2021.

As part of our approach, we have prioritised deployment of vaccines to countries based on multiple indicators including rates of COVID-19 community transmission, local health system capacity and the availability of medevac services. Our rollout remains flexible and responsive to changing local environments. All priority one and two countries have access to vaccines.

As at 3 June, we are aware of at least 3,150 Australian Government staff and dependants in the overseas network who have received one or more doses of a COVID-19 vaccine. This represents at least 44% of the overseas network.

The 2021-22 bilateral allocation is \$42.1 [million] and total ODA \$95.5 [million] - how is this being reallocated in the aftermath of the coup?

Are we utilising multilateral channels and what are they?

### **Answer:**

As a result of the coup, Australia redirected our development program away from working with government ministries and government-related entities. We are utilising multilateral channels among other trusted partners to deliver assistance post-coup.

The details of redirected bilateral development assistance to Myanmar for the 2021-22 financial year have not yet been finalised. Redirected funding in 2020-21 includes an estimated:

- \$4.5 million for food assistance through the World Food Programme (WFP)
- \$3 million to support the UN Population Fund's (UNFPA) work on sexual and reproductive health care, emergency obstetrics and support for survivors of gender-based violence
- \$4 million to support the Myanmar Education Consortium, implemented by Save the Children, which supports non-government education providers to deliver education services to marginalised children.
