**COMMUNITY CONSULTATION REPORT – AIR3024 WOOMERA RANGE  
REMEDiation FACILITES PROJECT**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the AIR3024 Woomera Range Remediation Facilities Project (the Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- was well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- had every opportunity to raise issues of concern or seek further information so that wherever feasible they could be addressed by Defence in its program of works.

The consultation activities undertaken included:

- Individual and group correspondence provided through existing relationships with the neighbouring property owners and managers;
- Correspondence sent by email to local groups, State and Federal members with individual briefings conducted where requested. A list of the members and groups consulted is at Annex A, with a short description of the outcomes of the consultation. An example of the correspondence sent to the members and respective groups is provided at Annex B;
- Advertisements in the local area, as detailed and listed at Annex C;
- A Public Information Forum, details listed at Annex D; and
- Promotion of the Project through the regional Defence liaison roles at RAAF Woomera, including the advertisement of the Project through the Annual Woomera Stakeholders and Open Day.

Key questions and issues raised by the Community through the Public Information Forum are listed at Annex E.

In general, the community feedback regarding the Project was positive. There was good support from the local communities as the Project provides the local residents, in particular Pastoral Lease Holders, clarity on the long term facilities planning to assist private development of pastoral land.

In conclusion, no significant issues have been identified during Defence's community consultation that will impact on the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the Community about the Project and to provide opportunities for the Community to raise concerns.

As a community or business member of the Woomera region, I am writing to you on behalf of The Department of Defence regarding the Woomera Range Remediation Facilities Project. The Woomera Range Remediation Facilities Project will involve the replacement of ageing Aerospace Test and Evaluation and Research and Experimentation equipment at the Woomera Test Range (WTR) and provide Defence with a modern Safety and Control System capable of testing complex networked technologies and advanced weapons systems.

The total estimated cost of the works at the Woomera Test Range is \$48.640 million, excluding Goods and Services Tax.

Subject to Parliamentary approval of the Project, construction is expected to begin in the first half of 2017 and will be completed in mid 2018.
