**COMMUNITY CONSULTATION REPORT FOR THE JP2008 PHASE 5B2  
WIDEBAND SATELLITE CAPABILITY – SATELLITE GROUND STATION-EAST  
FACILITIES PROJECT AT KAPOOKA MILITARY AREA, WAGGA WAGGA, NSW**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the JP2008 Phase 5B2 Wideband Satellite Capability – Satellite Ground Station-East Facilities Project at Kapooka Military Area, Wagga Wagga, NSW (the Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- a. was well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- b. had every opportunity to raise issues of concern or seek further information so that, wherever feasible, they could be addressed by Defence in its proposed program of works.

Multiple activities were undertaken to achieve these objectives, namely:

- a. Correspondence sent by post to State and Federal Members of Parliament, local Council and local Business Chamber with individual briefings conducted where requested. A list of stakeholders and a status of each briefing is provided at Annex A while an example of the standard invitation letter is provided at Annex B;
- b. Advertisements on Community Consultation sessions appeared in the local paper, the Daily Advertiser, in the classifieds / public notices section on 4, 8 and 10 July 2017, a copy of which is provided at Annex C; and
- c. A single Public Information Session was undertaken at the International Hotel Wagga Wagga on Tuesday 11 July 2017 between 4:00pm and 7:00pm. Details on the community's attendance at the session are provided at Annex D.

The feedback received from those consulted to date has been positive and supportive of the proposed works with no significant issues identified or concerns raised. A table summarising the issues and questions raised, and how these have been addressed by Defence, is provided at Annex E.

In conclusion, no significant issues have been identified during Defence's community consultation that will impact the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the community about the proposal and to provide opportunities for the community to raise concerns and questions.

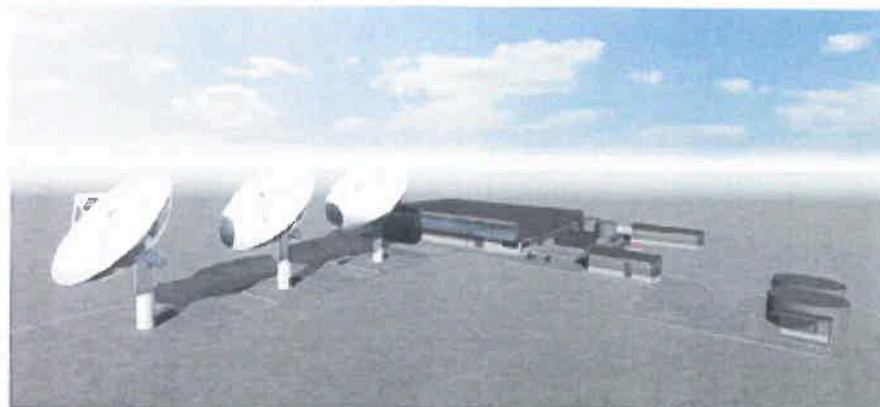

## **SUMMARY OF KEY ISSUES RAISED DURING PUBLIC INFORMATION SESSION**

A summary of the key issues raised during all consultation activities, as well as Defence's response to these issues, is provided in the table below.

**Overview:** Stakeholders were generally supportive of the proposed works and did not raise any significant issues or concerns that will impact the Project. Any issues or concerns raised were addressed by Defence at the meeting to the satisfaction of the community member.

<b>Issue/Question:</b>	<b>Raised by:</b>	<b>How each issue has been addressed:</b>
<i>Will water flows be affected by project?</i>	Members of the Public (Adjacent landholders)	No. The project will not touch existing detention or retention basins in the area nor construct any. A component of the project scope is overland flow (flood) protection, including swales and diversion flows to help prevent a flood washing over the site. This is designed to protect the facility from a 1 in 100 year event.
<i>Will diversion flows reduce water flow on property?</i>		Unrelated to flood protection, there may be a slight increase in runoff from the facility with the increased hardstand areas during rain events but this will drain into the existing drainage networks and will not affect adjacent properties.
<i>Will there be any changes to the retention dam?</i>		All new diversion flows drain into the existing drainage network. The drainage system has been designed such that it will not create erosion or pollution problems and will not interfere with natural drainage patterns of the site.
<i>Will there be any changes to fencing situation? (concern with respect to kangaroos as pests)</i>		The project will not touch existing detention or retention basins in the area nor construct any new ones.
<i>Will the facility impact existing telecommunications in the area, or wifi?</i>		No changes to the fencing separating Defence managed land from non-Defence managed land.
		No impact.
