Remarks:

- (a) The counting of convicted persons is based on the most serious offence for which the person was convicted;
- (b) This data does not include in transit, forwarded to another entity, attached or integrated proceedings;
- (c) From 2007 on, statistical data on proceedings at trial courts (first instance) started to be collected from the courts' computer system, thus representing the situation of the proceedings recorded on such system;
- (d) The offence of trafficking and illicit activities, simple or aggravated (including precursors) includes the offences of drug trafficking, aggravated drug trafficking and simple or aggravated trafficking (with precursors);
- (e) The offences of trafficking in very small amounts, less serious trafficking or trafficking-consumption include the offences of trafficking in small amounts and less serious trafficking, trafficking for consumption, attempted trafficking for consumption and trafficking in very small amounts/trafficking-consumption;
- (f) The offence of consumption related with drugs is based on the offence of trafficking and consumption at public or gathering places;
- (h) (-) null result/under statistical secrecy.

REMARK: The table shows the number of detainees who, on 21 August 2014, had been convicted in proceedings for these offences. The punishments applied correspond to the counting of the set of offences (both several drug-related offences and other types of offences) for which the detainees were convicted. As it is unlikely that a person is convicted for a single offence, it is difficult to divide into parts the several punishments applied to each offence and which are included in the global value.
