- 2. **Annual Workplan:** It is crucial that the EIAC publish its workplan on an annual basis. This proactive approach will provide a roadmap of the EIAC's intentions and activities, allowing for community feedback, engagement, and collaboration.
- Inclusivity in Membership: To truly represent the diverse voices of Australia, we firmly believe that the EIAC should include at least one First Nations person and one person with lived experience of economic disadvantage. These perspectives are invaluable and will enrich the Committee's understanding of the issues it seeks to address.
