## Alcohol Action Initiatives (AAIs)

Since early 2016, the focus of work with remote communities has been the development of Alcohol Action Initiatives (AAIs), which are community driven projects that develop local solutions and practical actions. The AAI program provides short term funding to support community action to minimise the harm caused by the consumption of alcohol through supply, demand and harm reduction strategies. Funding is available to communities that have participated in alcohol management planning processes.

AAIs are designed to:

- Reduce alcohol harms in the community and address one or more of the following:
  - Supply reduction: reducing alcohol consumption and related harm by managing the availability, accessibility and convenience of alcohol supply.
  - Demand reduction: changing individual attitudes, personal knowledge and behaviours to drinking alcohol and changing the community's tolerance of irresponsible and risky drinking.
  - Harm reduction: reducing harms to individuals and the community through influencing safe drinking choices and drinking environments and providing interventions that prevent further harms.

- Improve community safety and wellbeing of individuals, children, families and communities.
- Improve school attendance.
- Support community capacity building and enable communities to own and drive their AAI.
- Support leadership and governance of the AAI on the ground in the community.

In particular, there are a number of funded AAI programs in Maningrida and Wadeye in varying stages of completion over the 2019-2022 period provided in the table below:

## 3. What does the NTG think will be the major challenges and/or risks from the cessation of the Stronger Futures legislation?

Ensuring the Northern Territory receives the funding it requires to address the higher rates of need of Aboriginal Territorians living in remote and very remote communities is a continuing challenge.

Sustaining the effort and assistance provided by the Commonwealth in partnering with the NT Government to improve outcomes for Aboriginal Territorians must be a priority.

It would be unfortunate if the cessation of the Stronger Futures legislation was misconstrued by the Commonwealth that the many issues faced by Aboriginal Territorians had been addressed and were no longer a substantive issue.

#### 4. What differences in approach are expected as the NT enacts legislation for the regulation of remote stores, alcohol and land tenure?

##### Alcohol

Amendments to the *Liquor Act 2019* have already been enacted to establish the interim APA process.

A review of the *Liquor Act 2019* is also about to commence in accordance with section 320, which requires the Minister to undertake a review after three years after the date of its assent to 'determine whether the policy objectives of the Act remain valid and whether the terms of the Act remain appropriate for securing those objectives'. A report on the outcome of the review must be tabled in the Legislative Assembly within 12 months after the end of the three year period.

##### Remote Stores

It is anticipated that the Northern Territory's remote store licensing scheme will closely mirror that of the Commonwealth's scheme, but its application will be greater, resulting in more stores located in a remote community to be subject to the scheme.

##### Land Tenure

In preparation for the the sunseting of Stronger Future Act, the Northern Territory passed the *Associations and Liquor Amendment Act 2022*, on 17 May 2022, amending the *Associations Act 2003* to continue modifications made to it by the Stronger Futures Act around leasing and licensing in Community Living Areas.

The NT Government is considering options for longer term land reforms, and has prepared a Discussion Paper which aims to seek views on land use planning, land tenure and ownership arrangements that could be changed to facilitate investment and community development on Community Living Areas and Town Living Areas to allow these interests to be utilised to their full potential.

The Discussion Paper is currently progressing through the relevant NT Government approval processes and is anticipated to be publicly released shortly inviting submissions through the 'Have Your Say' website for a three month period.

Subject to the views of stakeholders, the NT Government will consider the need for any reforms to relevant legislation and policy to address the matters identified. The efficacy and practical viability of any land reform options will require assessment against various desirable objectives, like whether the options:

- facilitate economic development;
- enhance self-determination and local decision making;
- increase investment confidence;
- reduce regulatory and administrative burdens;

- reduce inappropriate land use; and
- increase landholder entity resilience and capability.

**5. Is it the view of the NT Government that the Stronger Futures legislation should have been allowed to sunset?**

Yes.

**6. Is the NT Government adequately resourced to support community safety, alcohol management, job opportunities and justice reinvestment community services without direct Commonwealth assistance?**

No and this is acknowledged by the Commonwealth.

Over the last seven years, the Commonwealth has provided support to the NT Government to deliver services to Aboriginal Territorians living in remote communities through the National Partnership on Northern Territory Remote Aboriginal Investment (NTRAI).

The NTRAI recognises that Aboriginal people in remote and very remote communities experience significantly poorer life outcomes than the rest of the nation (as measured by the Closing the Gap targets) and long term additional investment in services and infrastructure is required to accelerate action to address the high levels of need.

The NTRAI has been a key funding agreement between the Commonwealth and the Northern Territory. The first seven years of NTRAI was effective in facilitating more equitable access to vital services for Aboriginal people in remote areas. This includes:

- greater access to early childhood education;
- culturally safe family support to reduce the risk of children's re-entry into care and support for foster and kinship carers;
- doubled the amount of discrete, remote communities with a permanent police presence;
- delivered practical, locally supported educational, diversionary, cultural and/ or recreational activities, designed to reduce alcohol-related harm;
- increased interpreter access and reach; and
- 440 jobs created in service delivery, with around half filled by Aboriginal people.

The NTRAI has been extended until 30 June 2024 to continue existing service delivery. The extension allows sufficient time to develop a new funding agreement for remote Aboriginal investment over the next seven to 10 years.

Future NTRAI funding has the ability to continue and enhance effective programs that are providing vital services to remote Aboriginal Territorians and establish new programs to benefit remote Aboriginal Territorians. If sufficient funding is not received under the future arrangements, service delivery to remote Territorians will be impacted.

**7. What measures has the NT Government put in place and will still put in place as a result of the sunset of the Stronger Futures legislation?**

## 8. What actions are the NT Government taking to improve the housing situation for First Nations people?

The NT Government is committed to improving housing in remote communities with an investment of \$1.1 billion over 10 years. *Our Community. Our Future. Our Homes.* focuses on local decision making, engagement and planning. It also includes a focus on local participation to deliver the work, to promote local economic development and develop local skills to build and manage housing.

On March 2019, the Northern Territory and Commonwealth governments signed the [National Partnership for Remote Housing NT](#), securing \$550 million in Commonwealth Government funding from 1 July 2018 to 30 June 2023.

The Agreement aims to improve remote housing by reducing overcrowding for Aboriginal people in 73 remote communities and the 17 Alice Springs Town Camps.

The NT Government has welcome the Commonwealth's recent budget announcement of \$100 million towards housing and essential infrastructure in Homelands and an additional \$110 million towards the Remote Housing Program.

## 10. How have you involved First Nations communities in designing measures to follow after the sunseting of Stronger Futures? What was the feedback from the community?

Between May to 30 October 2022 there had been 245 face-to-face engagements, with 787 individuals (423 males and 394 females), across all regions. There have been further engagements with representatives of multiple affected areas, including town camps, outstations and communities, for example in discussions with Traditional Owners and Land Councils also being in attendance at multiple forums.

It is important to note that consultations with remote communities were affected by COVID-19 restrictions following a series of directions imposed by the Chief Health Officer over the period of June 2021 to May 2022.

- Top End – 33 communities
- Darwin, Palmerston, Litchfield – 24 communities
- Big Rivers – 71 communities
- East Arnhem – six communities
- Barkly – 11 communities
- Central Australia – 100 communities

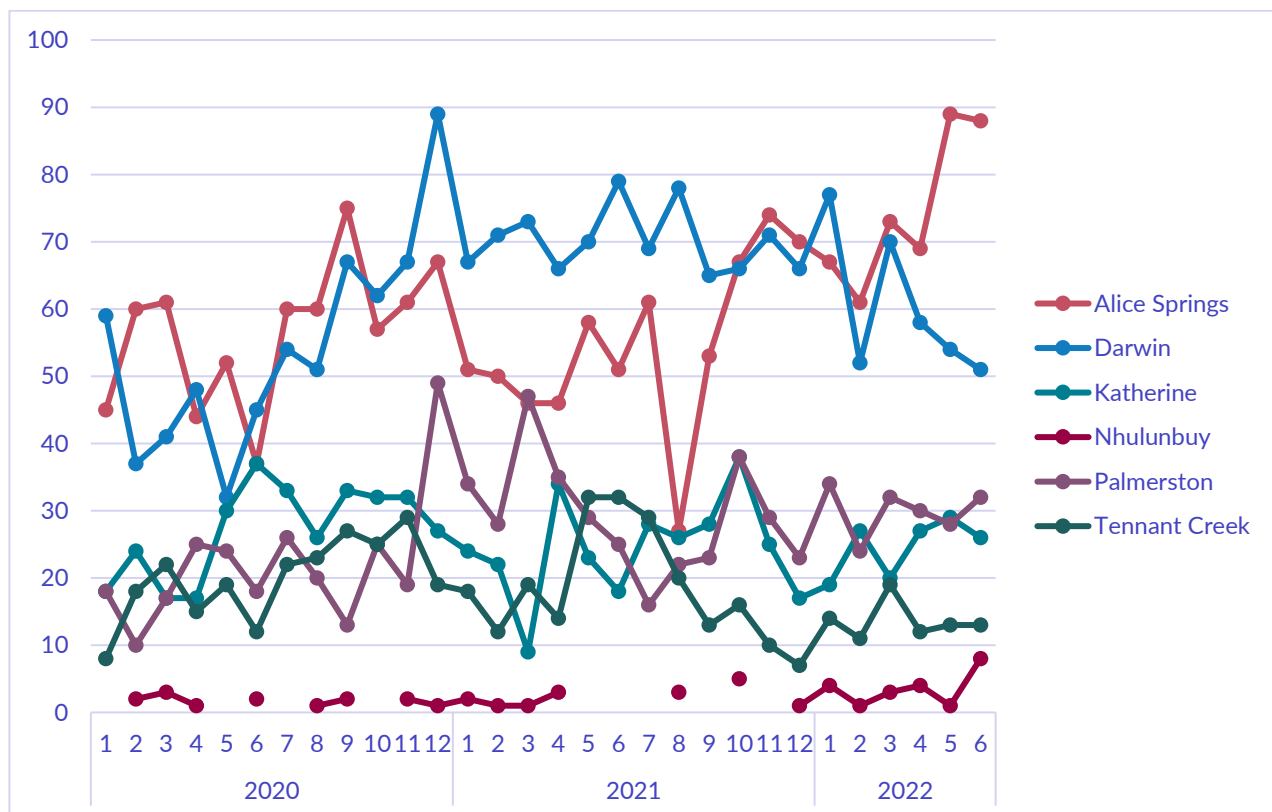

# **11. Has there been a measurable difference in outcome for First Nations people in the Northern Territory since the sunseting of the Stronger Futures legislation? Has there been a difference in reports of alcohol related and domestic violence or employment opportunities in remote communities since the sunseting of the legislation?**

It is difficult to assess whether the cessation of the Stronger Futures legislation has had any impact on employment opportunities in remote communities due to an absence of any direct correlation.

Operational intelligence from health, police and child protection agencies is not showing a substantial increase in alcohol related harm post cessation of Stronger Futures legislation. However, the trends in alcohol related harm indicators will be more readily identifiable as we now have a substantial period to analyse (i.e. a three month period).

Alice Springs was experiencing historically high levels of domestic violence and assaults prior to the cessation of Stronger Futures legislation. The below graph represents domestic incidents involving alcohol by regional centre from 2020 to June 2022.



Domestic violence continues to be an increasing problem across the Northern Territory, with Aboriginal women suffering unacceptably high levels of harm. The causes and contributing factors to domestic violence are complex, stemming from social and cultural attitudes and behaviours, and not simply a result of alcohol abuse, although alcohol and other drugs are significant reinforcing factors<sup>1</sup>.
