CHAIR: So you had skill sets, you shook the tree—I mean that in a constructive way—and then did some interviews and made some selections so you got the right kind of balance on each panel.

Ms Luchetti: That's correct.

CHAIR: Were the skill sets documented? As we do in the audit committee, we are all historical experts, but I'm just looking at whether there were any lessons learned. Would it have been better to document the criteria have some kind of a selection matrix? Ms Luchetti: We had our own internal process. I would have to take that in notice in terms of what we did. We had our own process broadly about the skills we needed. I think it's safe to say that we went through round 1 for integration translation; we learnt from that exercise; then we moved to round 2 thinking about different kinds of skills we may need or what worked and what didn't. We kept documentation in terms of working through with people and talking to them and writing down notes to make sure they met the criteria that we were looking for.

CHAIR: It's just the words 'we had our ideas about skills that you were looking for...we were broadly thinking about it.' One of the things which is a recurrent theme with the Auditor-General and certainly with this committee is what records and documentation were kept so people can be assured retrospectively that there was a robust decision-making process. I'm not arguing with the description of the process you went through; I'm more trying to understand why there wasn't a level of consistency or formality about it.

Ms Luchetti: I will have to take it on notice. I'm trying to remember my notes. I'll have to take it on notice in terms of how we did it. I'm sure I'll come to the spot in my briefing pack. CHAIR: If you could, that would be helpful.

ANSWER

The independent Assessment Committees were comprised of industry experts and specialists with experience and expertise in manufacturing, venture capital, commercialisation, Artificial Intelligence/digital, finance, business development, together with technical experts with experience across the six National Manufacturing Priorities areas (Space, Defence, Food & Beverage, Medical Products, Resources Technology & Critical Minerals and Recycling & Clean Energy).

Assessment Committee members were chosen through a process of shortlisting and interviews, based on their professional experience and qualifications.

The following is a summary of the process:

- a. The department identified the knowledge areas that would be required to assess the applications.
- b. Candidates were identified using existing networks from across the department.
- c. Validation of their suitability for the role was conducted by reviewing their professional history and performing due diligence checks.
- d. A shortlist resulted from a review of the pool of candidates against the knowledge areas. These candidates were invited by the department to participate.

CHAIR: ... Whose idea was it to make the Prime Minister the decider in chief?

Ms Luchetti: I'd have to take that on notice. It may have been a decision of cabinet, so I'd have to take that on notice.

CHAIR: It could be more likely a decision of cabinet; it could be a decision the PMO communicated to the minister.

Ms Luchetti: At the time, it was the Modern Manufacturing strategy, a \$1.5 billion strategy. That was considered by cabinet. These grant programs went through that process in terms of policy intent. So I'd have to take that on notice.

CHAIR: Okay.

ANSWER

It was a decision of Cabinet that the Prime Minister would be the decision maker for the MMI Collaboration Stream.

CHAIR: Why did the minister ultimately pick one project over another, given he had a shopping list?

Ms Shrives: I don't know that we have that information. The minister was asked to rank which projects he was supporting for funding, and that's the information we have.

CHAIR: The grant guidelines require decision-makers to receive written advice, which occurred, and to record reasons for decisions. What reasons for decision were recorded? Ms Shrives: We don't have that. I will say that is something that we are being more explicit about in the briefings that we now provide to ministers. It's something that we've reflected on and have improved our briefing templates in relation to, and we're working with our minister's office to help support that outcome.

CHAIR: Are you telling the committee there were no reasons for decision recorded anywhere? Ms Shrives: I've not—

Ms Luchetti: For collaboration, the reasons for decision were included in the letter from Minister Taylor to the Prime Minister. So that was outlined in the briefing that went there. In integration and translation, my understanding is that wasn't the case.

CHAIR: Let's just take them one at a time. In the letter from Minister Taylor to the Prime Minister there were reasons for decision set out—are we able to get a copy of that letter? That sounds like the only record of the reasons that large amounts of money were handed out. Ms Luchetti: I'll have to take that on notice.

CHAIR: I think we'd request one, if we can. One of the themes we're looking at through this inquiry is: Were the grant guidelines complied with? Did departments properly advise ministers? Were templates correct? In a previous hearing, we heard some examples of where templates actually got worse through multiple rounds, not better, which was curious. I think it was the industry department too, actually. One part of that is supporting decision-makers in their responsibilities, so it's good you've had some reflection and taken that on board. Could you take it on notice and give us a little more colour and movement about that process of improvement and reflection so that we can reflect good practice back in our report?

Ms Luchetti: Yes.

CHAIR: And I request a copy of the letter so we can form a view.

ANSWER

Reasons for decisions were not recorded for Round 1 of the Modern Manufacturing Initiative Integration and Translation streams. As a result, the department implemented improved templates and briefing documents for decision makers for all subsequent rounds of the Modern Manufacturing Initiative.

The department is unable to provide a copy of the letter detailing the recommendations from the Minister to the Prime Minister for the MMI Collaboration stream as the document is classified protected cabinet. The response to question 18 provides information on the projects that were supported for funding by the assessment committee, and the scoring assigned to each proposal by the assessment committee, that supported the decision making.

CHAIR: ... So that was the collaboration stream. In the other stream, what records were kept of why some projects were chosen and not others?

Ms Shrives: What we have from the minister in relation to that is just the ranking of the projects he was selecting.

CHAIR: So you just got a set of numbers back?

Ms Shrives: Yes.

CHAIR: Like a parent says to a toddler, 'Because I said so'?

Ms Pickworth: As my colleague has outlined, we don't have any further statements of reasons provided in those streams.

CHAIR: In those circumstances, when the department got that brief back, someone would have received that brief back?

Ms Pickworth: I think we're probably heading towards the limits of the collective knowledge of who's at the table. We can certainly take on notice what the process was upon receipt of that brief back—unless you're able to?

Ms Shrives: No.

Ms Pickworth: We'd have to take it on notice. We can take it across the three streams of the process and how reasons were recorded and what the process was from the department's perspective upon getting the advice back from the minister.

ANSWER

In each round of the Modern Manufacturing Initiative, the Minister was presented with a table identifying those projects the Assessment Committee determined were suitable for funding and those that were not. This table also indicated the assessment score assigned to each proposal. The department requested information on the Minister's reasons for his decisions on Round 1 Tranche 2 and Round 2, however, the information was not provided to the department.

We continue to improve our processes and to ensure that Minister's and their offices have a shared understanding of the Minister's obligations when making decisions on grant programs.

For the Modern Manufacturing Initiative Collaboration Stream, the Minister provided his recommendations for projects to fund, together with his reasons, in a letter to the Prime Minister.

CHAIR: One of the things we've interrogated with other agencies—and the Auditor-General has observed it in a number of audits—is there's a degree of obligation and responsibility on a department and a proactive expectation that you properly support and advise decision—makers. Sometimes ministers don't know the rules. They're new; they're busy; they think that the paperwork is fine, but it actually doesn't comply. That's really your responsibility—to put that forward in the correct fashion.

Ms Pickworth: Part of what my colleague was saying before is that we certainly have learned some broad lessons and improved our briefing and our templates and things like that, because I think we've recognised that was not where we wanted it to be.

CHAIR: Good. We'll get some supplementary info that we can draw on, so that's good to hear. But the other responsibility is—and it's a difficult issue—where departments observe that ministers haven't complied with the rules, like sending back a brief with a set of rankings and no reasons for decisions, which clearly just does not comply with the Commonwealth grants rules, there's an obligation on departments to at least go back to ministers or decision-makers and say: 'Well, you haven't recorded reasons. You need to. Here are the grant guidelines.' And the Auditor-General observed this in previous hearings. Now, ultimately, if a minister chooses to ignore that, you've fulfilled your obligation, but did you go back to Minister Taylor and tell him he didn't follow the rules?

Ms Pickworth: I think we'd have to take that on notice as well, Chair, in terms of whether there was further follow-up upon receipt of that brief.

CHAIR: We have heard examples in previous hearings where there was; we have heard examples where there wasn't.

Ms Shrives: I'm not aware that there were, but I'll check and confirm.

ANSWER

In each round of the Modern Manufacturing Initiative, the Minister was presented with a table identifying those projects the Assessment Committee determined were suitable for funding and those that were not. This table also indicated the assessment score assigned to each proposal.

The Minister was asked to use this table to indicate his decisions on which projects to fund by numbering them in order of his preference or, in the case of the Collaboration Stream, indicating his agreement.

In the decision brief provided for Round 1 Tranche 1 of the Integration and Translation Streams of the program, the Minister was only asked to indicate his decisions on which projects to fund by numbering them in order of his preference. It was recognised in our review of the processes undertaken to implement subsequent Rounds of the program that the department should have also requested the Minister indicate his reasons. This process step was added and has since been updated in the department's briefing templates.

We continue to improve our processes to ensure that Ministers and their offices have a shared understanding of the Minister's obligations when making decisions on grant programs.

CHAIR: ... How many grants are we talking about again that were recommended and funded? Ms Luchetti: In collaboration we had 86 applicants, and 17 grants were recommended. And in integration and translation?

Ms Shrives: In round 1 for integration and translation we had 765 applications, of which 34 projects were funded. In round 2 across those programs there were 432 applications, of which 51 were selected for funding.

CHAIR: Right. The minister received a table from the assessment committee with the name, project, stream, dollars sought, total project value and the score by the assessment committee. Was that on both streams?

Ms Shrives: For integration and translation, yes.

CHAIR: That was for integration and translation. Could you perhaps take on notice, just for the ones that had a 'yes' in them, a list of the projects and what the scores were and then identify which ones were ultimately chosen?

Ms Shrives: Yes.

CHAIR: I'm just trying to keep it as narrow as possible so we can get a sense of how close the final decisions were to the scores. Do you know how many had a 'yes' next to them? Ms Shrives: I don't, I'm sorry. It was a long list though.

Ms Luchetti: I don't recall.

CHAIR: Okay. That would be useful for both streams. For the collaboration, the assessment committee and then this extra strategic review occurred. Did the minister receive the same kind of information, with a score for those as well?

Ms Luchetti: Yes, that's correct. That's my understanding.

CHAIR: Can you take on notice then the same question for that stream?

Ms Luchetti: Yes, will do.

ANSWER

The attached tables provide information on the projects that were supported for funding by the assessment committee, the scoring assigned to each proposal by the assessment committee and an indication of the applications selected by the Minister (for the Integration and Translation Streams), and those recommended for funding by the Minister (for the Collaboration Stream).

Across the Integration and Translation streams, the Minister decided 100 projects, in priority order, should be funded, subject to available funding. Fifteen selected projects, as highlighted in the attached table, were not able to be progressed within the available funding.

Information that may identify applicants and that is not in the public domain has been excluded from these tables.
