## Australia's Advocacy for the Abolition of the Death Penalty

- 1. The Law Council of Australia attended a hearing of the Joint Standing Committee on Foreign Affairs, Defence and Trade's (the Committee) inquiry into *Australia's Advocacy for the Abolition of the Death Penalty* on 17 November 2015.
- 2. In response to a question from Mrs Jane Prentice MP at the hearing, the Law Council has prepared this supplementary submission to further inform the Committee's consideration of this issue.
- 3. Mrs Prentice has requested additional information on the work of the Law Council's activities and the potential to leverage its regional associations in support of Australia's advocacy for the abolition of the death penalty.

Legal association networks

- 4. The Law Council represents the legal profession at the national level, speaks on behalf of the state and territory law societies and bar associations on national issues, and promotes the administration of justice, access to justice and general improvement of the law. The Law Council also represents the Australian legal profession overseas, and maintains close relationships with legal professional bodies throughout the world at the international, regional and bilateral level.
- 5. For example, the Law Council has close working relationships with international peak bodies, including the International Bar Association, LAWASIA, the Commonwealth Lawyers Association, the Presidents of Law Associations in Asia, the South Pacific Lawyers Association and bilaterally with several counterpart peak bodies in the region and more broadly, including in China, India, Japan, Malaysia, Singapore and the United States of America.
- 6. These strong ongoing partnerships can form a broad base for advocacy for the abolition of the death penalty. There is the potential to reach out to these organisations to form alliances on the issue collectively at an international level and bilaterally with like-minded counterparts.

- 7. Generally, the Law Council has found that, among the legal profession, evidence-based and international law messaging while remaining sensitive to a particular country's political, social and economic circumstances, is most likely to generate momentum. The Law Council's partnerships also provide an opportunity to gain a better understanding of advocacy strategies that may resonate with the legal profession across the region, noting that this will vary from country to country.
- 8. The Law Council can also support the judiciary domestically and overseas in promoting alternative sentencing options other than capital punishment.
- 9. Further, message delivery is an important consideration. One-on-one lobbying visits, meetings, legal association conferences and workshops are some of the different formats that may be utilised by the Law Council for delivering a message on global abolition of the death penalty.

Death penalty symposium

- 10. The Law Council proposes to host a symposium on the abolition of the death penalty in the first half of 2016.
- 11. The goal of the symposium will be to identify measures by which Australia can contribute effectively to the abolition of the death penalty internationally.
- 12. The Law Council intends to invite a cross-section of representatives from parliament, the legal profession, civil society, government representatives, academia, business and faith based organisations.
- 13. The symposium will include key note speeches, panels and open discussion, with the aim of developing a joint communiqué from participants.
- 14. The Law Council looks forward to continuing to work with the Committee and the Australian Government on achieving global abolition of the death penalty.

## Attachment A: Profile of the Law Council of Australia

Between the meetings of Directors, policies and governance responsibility for the Law Council is exercised by the elected Executive members, led by the President who normally serves a 12 month term.
