Management of the Building Better Regional Cities Program: Public Hearing 26 June 2014 – Questions Taken on Notice

1. Pp8-9 Dr Hendy: 'What process did you go through to go back to the minister to advise him of improved value for money such that this could potentially be recommended? Was there any process at all?

Following advice from the Minister's Office of Minister O'Connor's intended final decision on the 17 projects to be funded under the BBRC, the Department sought the Minister's permission to commence confidential negotiations with the successful councils (MN12-001064; 8 May 2012).

In early June 2012, the Department advised the Minister that confidential negotiations on the funding agreements with successful applicants had commenced and that the final amount provided to successful applicants would be subject to further verification and the negotiation of funding agreements (MN12-001089).

In late June 2012, the Department advised the Minister of the outcomes of negotiations and requested approval to enter into funding agreements with 11 councils (MN12-001460). The Department advised that, overall, negotiations had resulted in improved affordability outcomes and/or progress achieved on the funding agreements. In this minute, the Department also advised the Minister that several of the projects required further negotiation (Tamworth, Wagga Wagga, Lismore, Maitland and Wyong) and requested that the Maitland project be provided additional funding. The Department also sought agreement to not fund one project (Latrobe Council) as the proponent was unable to provide any direct affordability measures.

The Department further briefed the Minister on BBRC projects as follows:

- Maitland project August 2012 (MN12-002021);
- Tamworth project September 2012 (MN12-002080);
- Mandurah project September 2012 (MN12-002023);
- Wagga Wagga project September 2012 (MN12-001793).
