9	Ms Mills: In addition, we have, within specialist areas such as Hansard, a peer training program—and I can certainly have the assistant secretary of that area explain to you how Hansard staff are trained. It is largely on-the-job and peer-supported training.	Clarification: Trainee Hansard editors progress through a structured training program to become Hansard editors. They are each supported in their training by their mentor (an experienced Hansard editor allocated to assist them) and by their Assistant Director.

Clarification: Two Hansard editors have been taken offline until the end of 2014 to coordinate training and support the current large cohort of trainees in progressing through the training program. This is in addition to the mentors that are allocated to assist each of the trainees.
11	Ms Greening: Until 2012, we had two people full-time looking after our trainees.	Clarification: two people (PEL 1s) developed the training program and managed the trainees, but only one of them (who was a former editor and senior editor) delivered the actual training.
11	Ms Greening: The trainees are split across four teams, and the assistant directors have prime responsibility for working with the trainees and the training program. The mentors are allocated time during the sitting weeks to assist their trainees, so they are on hand to help them with and subedit their work, because all trainees' work is subedited. So, yes, it is an impost at the moment but it is one that we are working through.	Clarification: Subediting of the trainees is not always done by their mentor; sometimes it is done by other PSL6 editors. However, it is correct that all trainee's work is subedited.

All pinks and greens from turns completed by a PSL5 trainee editor are subedited before going to senators and members.

47	Ms Greening: I have been a manager for over 10 years and in most of my management roles I have not had in-depth experience of the services that I am responsible for delivering. In this current role, not only am I responsible for the Hansard service; I am also responsible for the parliamentary AV service and I do not have any experience managing parliamentary AV either.	Correction: I have been a manager for over 15 years Correction: I am responsible for the parliamentary AV service and I do not have any experience doing parliamentary AV activities either.
47	Ms Greening: We had a team of two who were responsible for providing training services. That team has only been place for approximately four years. We have moved away from having that team responsible for training people. When I talk about trainees, you said four. It is more like eight per year, but for the last few years those people had been part time. So they had only been working when parliament sat. We had two full-time equivalents managing the training for eight individuals, which was the equivalent of four FTE.	Correction: should read 'been in place'.
