**Subject: 457 visa and TSS nominations approved between base salary points**

**Asked by:** Julian Hill

**Question:**

1. For 2017-18, how many 457 visa or TSS nominations were approved with base salary between \$53,900 and \$58,500?
2. For 2018-19, how many 457 visa or TSS nominations were approved with base salary between \$53,900 and \$60,000?
3. For 2019-20, how many 457 visa or TSS nominations were approved with a base salary between \$53,900 and \$62,000?

**Answer:**

For the 2017-18 program year, 9,798 Temporary Work (Skilled) (subclass 457), and 711 Temporary Skill Shortage (subclass 482) nominations were approved with a base salary between \$53,900 and \$58,500 per annum.

For the 2018-19 program year, 3,257 Temporary Work (Skilled) (subclass 457), and 7,646 Temporary Skill Shortage nominations were approved with a base salary between \$53,900 and \$60,100 per annum.

For the 2019-20 program year, 68 Temporary Work (Skilled) (subclass 457), and 6,590 Temporary Skill Shortage nominations were approved with a base salary between \$53,900 and \$62,000 per annum.
