What is the furthest distance a participant is required to travel in order to attend their appointment with their ParentsNext provider?

Answer

Participants can travel up to a maximum of 60 minutes each way to attend an appointment with their ParentsNext provider. Providers have discretion to conduct appointments flexibly, such as via telephone or video conference, where appropriate and the participant agrees. Participants can also request to transfer to a closer provider, where one is available.

Question

PCI - ParentsNext: Outcomes

How many participants have moved from the ParentsNext program to permanent employment?

Answer

ParentsNext is a pre-employment program and participants have no obligation to look for work. Notwithstanding this, a combined 1,005 participants have exited the program due to stable employment, 556 in the 2016–2018 program and 449 to 31 December 2018 from the national program.

'Stable employment' is defined as the participant having remained in employment for 12 consecutive weeks for an average of at least 15 hours per week (or 30 hours per fortnight).

More than 9,800 parents in the program started employment since 4 April 2016.
