COMMUNITY EMPLOYMENT AMENDMENT BILL 1986

DIGEST OF BILL

**Purpose**

To extend the Community Employment Program by three years to 30 June 1989.

**Background**

The Community Employment Program (CEP) was introduced in August 1983 to provide short-term employment and work experience for disadvantaged people, particularly the long-term unemployed. Preference is given to people from specially disadvantaged groups, including Aborigines, people with disabilities and migrants with language difficulties.

The CEP has two elements. The States and Territories element is jointly administered by the Commonwealth and the State and Territory governments and provides for projects to be sponsored by State and local government bodies, community groups or other bodies. State Governments are required to contribute at least 30% of the cost of approved projects and the other sponsors at least 20%, though contributions from community groups can be reduced or waived in special circumstances. The Commonwealth element is directly administered by the Commonwealth and provides for projects to be sponsored by Commonwealth departments and instrumentalities and by Aboriginal communities located in remote areas. This element is wholly Commonwealth funded.

In 1983-84, 29 597 people commenced jobs under CEP and Commonwealth expenditure on the program totalled \$285.42 million. In 1984-85, 45 912 people commenced jobs under

CEP. Expenditure in that year totalled \$405.54 million. The average duration of jobs under CEP decreased from 28.1 weeks in 1983-84 to 26.7 weeks in 1984-85.[1] In the May 1985 statement on Government Expenditure Savings the Treasurer announced that CEP funding was to be reduced by \$120 million for 1985-86.[2] Expenditure for 1985-86 is estimated to be approximately \$291 million.[3]

In March 1985 the Department of Employment and Industrial Relations conducted a survey of 600 people (of whom 552 responded) who had completed CEP jobs six months prior to the survey. The survey aimed to determine the employment status of CEP participants. The results of the survey are contained in the following table:

Under section 12 of the Community Employment Act 1983 (the Principal Act) approvals for new projects under CEP was to cease on 30 June 1986. On 10 December 1985 the Minister for Employment and Industrial Relations announced that CEP was to be extended to 30 June 1989.

### Main Provisions

Clause 3 will amend section 12 of the Principal Act to insert the new termination date of 30 June 1989.
