- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
- 2. Message from the Governor-General.—Assent to Bills.—The following Message from His Excellency the Governor-General was received, and was read by Mr. Speaker:

- 3. Secret Meeting.—Mr. Curtin (Prime Minister) moved, by leave, That a Joint Meeting of Members of the Senate and of the House of Representatives be convened for eight o'clock p.m. this day for the purpose of discussing in secret the present war and hearing confidential reports in relation thereto. Question—put and passed.
- 4. Business of the House-Ministerial Statement.-Mr. Curtin (Prime Minister) made a Ministerial Statement with respect to the sittings of the House and the proposed reference of the Constitution Alteration (War Aims and Reconstruction) Bill to a special committee.
- 5. Social Security—Joint Committee—Fifth Interim Report.—Mr. Barnard, Chairman, brought up the Fifth Interim Report from the Joint Committee on Social Security, and moved, That the Paper be printed.

Question—put and passed.

6. Papers.—The following Papers were presented, by command of His Excellency the Governor-General— Lend-Lease and Reciprocal Lend-Lease Arrangements between the Governments of the Commonwealth of Australia and the United States of America.

11. Message from the Governor-General.—Dairying Industry Assistance Bill 1942.—The following Message from His Excellency the Governor-General was presented, and was read by Mr. Speaker:

GOWRIE,

Governor-General.

Message No. 92.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the granting of Assistance to the Dairying Industry with the object of aiding the Prosecution of the War, and for other purposes.

Canberra, 8th October, 1942.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Chifley (Treasurer) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to provide for the granting of Assistance to the Dairying Industry with the object of aiding the Prosecution of the War, and for other purposes.

Question—put and passed. Resolution to be reported.

The House resumed; Mr. Prowse reported accordingly.

Mr. Chifley moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question—put and passed. The Resolution reported from the Committee was read, and, on the motion of Mr. Chifley, was adopted by the House.

Ordered-That Mr. Chifley and Mr. Scully do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Chifley then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Chifley moved, That the Bill be now read a second time.

Debate ensued.

Mr. Ryan moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.
