- (1) its cuts to child care (\$820 million over two budgets, leading to increased fees and reduced childcare assistance, lower quality care, and closure of services);
- (2) the chaos it has brought on the industry (particularly outside school hours care) by its mismanagement of the payments arrangements, despite many warnings from the industry; and
- (3) in particular, the uncertainty it has caused the industry, first by changing its mind on the payment arrangements, and then by bringing forward an interim measure, so that the only certainty is that the system will change again within 30 months".

10 PRIME MINISTER—MOTION OF CENSURE

Mr Beazley (Leader of the Opposition), by leave, moved—That this House:

- (1) censures the Prime Minister:
 - (a) for his unwillingness to enforce proper standards in relation to his Resources and Energy Minister, who has breached the requirements of both the Prime Minister's Guidelines on Ministerial Conduct and the Senate's Register of Senators' Interests;
 - (b) for his approval of the arrangement whereby Senator Parer was allowed to continue to own—through a company of which he and his wife are the sole directors and owners—coal-mining shares worth in excess of \$2 million, despite the fact that this is likely to conflict with his public duty as Minister for Resources and Energy;
 - (c) for his approval of Senator Parer's failure to divest himself of shares, owned personally in QCMM Group (ESP) Pty Ltd, and through Investment Management Pty Ltd (IMPL) in Queensland Coal Mine Management Pty Ltd (and through that entity in a number of other companies in the area of his portfolio responsibility); and
 - (d) for his sweeping aside Senator Parer's failure to comply with the requirements of the Senate's Register of Senators' Interests, in that Senator Parer's Register of Interests statement:
 - (i) fails to list shares held by IMPL;
 - (ii) fails to list shares held personally by the Minister in QCMM Group (ESP) Pty Ltd; and
 - (iii) fails to identify his coal mining investments as a potential conflict of interest:
- (2) condemns the Prime Minister for not dismissing the Minister for Resources and Energy for his clear breaches both of the guidelines on the conduct of ministers and of the requirements of the Senate's Register of Senators' Interests; and
- (3) further condemns the Prime Minister for failing to disclose in detail the basis for his departmental Secretary's concluding that there is no conflict of interest involved in the Minister's ownership of significant coal mining interests.

Debate ensued.
