3 SUSPENSION OF STANDING AND SESSIONAL ORDERS MOVED

Mr Crean moved—That so much of the standing and sessional orders be suspended as would prevent the Prime Minister coming into the House and fully disclosing his association with the Menzies Research Centre Limited, in particular:

- (1) why he failed to declare his directorship on the Register of Pecuniary Interests:
- (2) whether in presiding over the Cabinet meeting which agreed to grants totalling \$400,000 to the company whilst still a director he declared his interest and absented himself from the meeting;
- (3) whether in presiding over the Cabinet meeting which agreed to allowing tax deductions for gifts of the value of \$2 or more made to the company whilst still a director he declared his interest and absented himself from the meeting;

- (4) the connection between the Short-Gibson-Moore shares affair and his decision to resign as director and the reason he failed to declare his resignation; and
- (5) the extent of the direct personal benefit he has gained, as Leader of the Liberal Party, from the work of the Menzies Research Centre Limited.

 - (a) leave Australians open to continued violations of their basic human right to privacy; and
 - (b) damage the trading prospects of many Australian information technology and information management companies, particularly in respect of trading opportunities with the European Union, resulting in the loss of Australian jobs in these vital emerging sectors of the economy".

9 PRIME MINISTER—MOTION OF CENSURE

Mr Beazley (Leader of the Opposition), by leave, moved—That this House censures the Prime Minister:

- (1) for breaching Ministerial standards in relation to (a) his own Guidelines on Ministerial Conduct and (b) the House of Representatives Register of Members' Interests in that:
 - (i) he failed to disclose his directorship of the Menzies Research Centre Limited, which he held for the first seven months of his Prime Ministership; and
 - (ii) he placed himself in a position of conflict of interest between his public duty and his directorship of that company;
- (2) for presiding over a Cabinet meeting which agreed to \$400,000 worth of grants to Menzies Research Centre Limited, as well as agreeing to tax deductibility for donations to the company, whilst he was a director of the company in a clear conflict of public duty and private interest;
- (3) for his weak and secretive attempt to avoid both public scrutiny of his directorship and the need to reveal his breach to former Ministerial colleagues he had forced to resign for similar breaches of his Guidelines on Ministerial Conduct: and
- (4) for his latest contortions and re-definition of the meaning of his own guidelines to suit his political needs, again doing so in a manner which has no regard to the standing of those guidelines, or to their consistent application, credibility or transparency.
