Mr Andren, from 141 residents of New South Wales, praying that any further government sale of Telstra be opposed.

Mr K. J. Andrews, from 17 petitioners, praying that action be taken to remove the exclusion of members of the Royal Australian Navy, who served in the Malaya campaign, from repatriation benefits under the Veterans' Entitlements Act.

Mr Bevis, from 1446 residents of Queensland, praying that a full and independent cost-benefit analysis of all runway options be taken before any single runway option is implemented at Brisbane Airport.

Mrs Crosio, from 2157 residents of Sydney South West and Sydney West, praying that any plan to construct a second airport in the Sydney airshed be abandoned immediately.

Mr Downer, from 99 petitioners, praying that the Minister for Health and Family Services be instructed to negotiate a fair deal for general practitioners and their patients in the setting of Medicare rebates.

Mr Fahey, from 219 petitioners, praying that certain actions be taken to ensure the conduct of free and fair elections in Cambodia.

Mr Fahey, from 99 petitioners, praying that certain action be taken to prevent political violence in Cambodia and install a truly democratically elected Government.

Mr Jenkins, from 58 residents of Victoria, praying that legislation that would impact upon existing quality, affordable childcare not be passed.

Mr Jenkins, from 51 residents of Victoria, praying that the decision to allow mining at Jabiluka be reversed.

Mr Jenkins, from 3000 residents of Victoria, praying that a Medicare office be established at Epping Plaza Regional Shopping Centre, Epping, Vic.

Mr Jull, from 1002 members of the Coombabah Branch of the Paradise Point and Northern Districts Progress Association Incorporated, praying that a general post office be established near the shopping centre at Coombabah, Old.

Mr Lee, from 10 036 petitioners, praying that the unfairness of prohibiting the use of the term "drug free" in describing and advertising vitamin and herbal remedies be recognised.
