16 FURTHER 1998 BUDGET MEASURES LEGISLATION AMENDMENT (SOCIAL SECURITY) BILL 1999—SENATE'S REQUESTS

The order of the day having been read for the consideration of the amendments requested by the Senate—

Mr Anthony (Minister for Community Services) moved—That the requested amendments be made.

Debate ensued.

Closure

Mr Anthony moved—That the question be now put.

Question—That the question be now put—put and passed.

And the question—That the requested amendments be made—was put accordingly and passed.

On the motion of Mr Anthony, Government amendments (1) to (3) were made together.

Mr Anthony moved—That in the message returning the Bill to the Senate, the Senate be requested to reconsider the Bill in respect of the amendments made by the House of Representatives to the Bill.

17 TELECOMMUNICATIONS (INTERCEPTION) AMENDMENT BILL 1999

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Williams (Attorney-General), the Bill was read a third time.

18 DIESEL AND ALTERNATIVE FUELS GRANTS SCHEME (ADMINISTRATION AND COMPLIANCE) BILL 1999

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Crean (Deputy Leader of the Opposition) who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"whilst not declining to give the Bill a second reading the House condemns the Government for:

- (1) continuing the uncertainty in the transport industry by not releasing the details of the boundaries of urban conurbations for the purposes of the Diesel and Alternative Fuels Grants Scheme (the Scheme);
- (2) not disclosing, prior to the last election, the new powers being proposed for the Commissioner of Taxation to stop, detain and search vehicles;
- (3) imposing a complex new layer of administration on transport operators in connection with the Scheme, in addition to the new compliance burden associated with the Goods and Services Tax; and
- (4) its failure to disclose the basis of its claims that the programs agreed with the Democrats will counter the greenhouse gas increasing effects of the Scheme."

Debate continued.

Debate adjourned (Mr Truss—Minister for Agriculture, Fisheries and Forestry), and the resumption of the debate made an order of the day for the next sitting.

19 ADJOURNMENT

Mr Truss (Minister for Agriculture, Fisheries and Forestry) moved—That the House do now adjourn.

Debate ensued.

Question—put and passed.

And then the House, at 10.57 p.m., adjourned until tomorrow at 9.30 a.m.
