Opposition amendment (1) to proposed Government amendment (4) negatived.

Government amendment (4) agreed to.

On the motion of Mr Williams, by leave, Government amendments (5) to (24) were made, together.

Mr Williams moved Government amendment (25).

Mr McClelland, by leave, moved Opposition amendments (2) and (3) to proposed Government amendment (25).

Debate continued.

Opposition amendments (2) and (3) to proposed Government amendment (25) negatived.

Government amendment (25) agreed to.

On the motion of Mr Williams, by leave, Government amendments (26) to (94) were made, together.

Bill, as amended, agreed to.

Consideration in detail concluded.

On the motion of Mr Williams, by leave, the Bill was read a third time.

## 6 VETERANS' AFFAIRS LEGISLATION AMENDMENT (BUDGET MEASURES) BILL 2000

#### 12 PUBLIC WORKS—PARLIAMENTARY STANDING COMMITTEE—REFERENCE OF WORK—PROPOSED ABC PERTH ACCOMMODATION PROJECT, EAST PERTH, WESTERN AUSTRALIA

Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration), pursuant to notice, moved—That, in accordance with the provisions of the *Public Works Committee Act 1969*, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for consideration and report: Proposed ABC Perth Accommodation Project, East Perth, Western Australia.
