The Speaker said that while he understood the Member's concerns and his claim that the execution of the warrant had meant that officers involved had seen confidential material relating to his parliamentary duties, he had seen no evidence that improper interference, as required by section 4 of the Parliamentary Privileges Act, had occurred. Accordingly, he was not able to allow precedence to a motion on the matter.
