2 SUSPENSION OF STANDING AND SESSIONAL ORDERS MOVED

Mr Beazley (Leader of the Opposition) moved—That so much of the standing and sessional orders be suspended as would prevent the Leader of the Opposition moving a motion requiring the Government to immediately instruct the Secretary to the Department of the Treasury and the Secretary to the Department of Finance to publicly provide a report on the Commonwealth's economic and fiscal outlook, noting:

- (a) the significant full time job losses since the introduction of the GST;
- (b) the serious fiscal deterioration associated with backflips on the GST;
- (c) the Howard/Costello Government as the highest taxing government in our history;
- (d) the halving of Australia's growth rate as a result of the GST, and before the world economic downturn; and
- (e) the doubling of Australia's inflation rate in the year of the GST; so that:
- (a) Australians are given an honest picture of the state of the Commonwealth's books ahead of the forthcoming federal election; and
- (b) all parties have the opportunity to responsibly detail their financial commitments before the calling of the election;

and the motion being debated forthwith.

13 MIGRATION LEGISLATION AMENDMENT (JUDICIAL REVIEW) BILL 2001

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Sciacca who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"whilst not declining to give the Bill a second reading, the House:

- (1) expresses its concern that amendments passed by the Senate that have attempted to exclude the original jurisdiction of the High Court in migration matters may be found to be unconstitutional or ineffectual;
- (2) observes that the Government is yet to table its legal advice which confirms the constitutionality or efficacy of these measures;
- (3) expresses its concern that the amendments may actually increase the number of migration decisions challenged in the High Court which will further delay the processing of migration cases and result in a further drain on our legal system;
- (4) expresses its concern that the Government has not addressed the issue of vexatious or unwarranted proceedings being commenced as a tactical delay to the implementation of migration decisions;

- (5) notes that the Opposition provided to the Minister for Immigration and Multicultural Affairs an alternative proposal to provide a fair but speedy form of judicial review in the form of a 'one stop shop' at the Federal Magistrates level; and
- (6) expresses its disappointment that the Government has not provided a more constructive response to that proposal".

36 MESSAGE FROM THE SENATE—TAXATION LAWS AMENDMENT BILL (NO. 6) 2001

Message No. 731, 27 September 2001, from the Senate was reported returning the Taxation Laws Amendment Bill (No. 6) 2001 with amendments.

Ordered—That the amendments be considered forthwith.

On the motion of Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration), the amendments were disagreed to, after debate.

Mr Slipper presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate Amendment No. 1

The proposed amendment would make sanitary products GST-free. It would require thousands of businesses to change their computer and accounting systems and the Tax Office would need to make rulings on definitions as what has been proposed differs from the former WST exemption.

The House of Representatives does not accept this measure.

Senate Amendment No. 2

The proposed amendment would make lactation aids GST-free. This would require thousands of businesses to change their systems to define what is GST-free or taxable under the proposed amendment. The proposed amendment also does not attempt to define exactly what a lactation aid might be, thus requiring Tax Office rulings.

The House of Representatives does not accept this measure.

Senate Amendment No. 3

The proposed amendment makes funeral services GST-free. This amendment is poorly defined and will create definitional problems, complexity, and uncertainty not only for the funeral industry but for thousands of other businesses. For example, venues would be taxable if provided for weddings, but

GST-free if provided for funerals. Flowers would be taxable if provided for weddings, but GST-free if provided for funerals.

The House of Representatives does not accept this measure.

Senate Amendment No. 4

The proposed amendment would make long term accommodation in a caravan park GST-free. Under the GST, caravan park owners have the choice of charging a concessional 5.5% GST on their long term accommodation and claiming full input tax credits or not applying the GST to rents, which means that they cannot claim input tax credits. This ensures that long term residents of caravan parks are treated fairly compared to those who rent a house or flat. The proposed amendment would provide residents of caravan parks with GST treatment which is more favorable compared to that available to others in rental accommodation.

The House of Representatives does not accept this measure.

On the motion of Mr Slipper, the reasons were adopted.

The Speaker made the following statement:

My attention has been drawn to the fact that the Office of Parliamentary Counsel (OPC) has provided a statement of reasons as to why some of the Senate amendments to this Bill should be moved as requests. Copies of relevant papers are available from the Clerk.

As I understand OPC took this view because the amendments in question had the effect of reducing the availability of deductions to certain taxpayers, and therefore increasing the burden of taxation on those taxpayers, contrary to the third paragraph of section 53 of the Constitution.

The Senate has, however, made the alterations as amendments and not as requests.

For its part, the House has taken the view that the restrictions of the third paragraph of section 53 apply to Bills relating to taxation, as well as those relating to expenditure. Consistent with this view, the House has objected to actions of the Senate in proceeding to make as amendments some alterations to bills dealing with taxation.

It is ultimately a matter for the House itself whether to object to such actions.

In this case Members may take the view that, despite the section 53 issue, the circumstances in which the House finds itself and the wider interest in having the bill settled without delay would not make it inappropriate for the House to proceed to consider the amendments as amendments and not take objection on constitutional grounds.

Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration) moved—That:

- (1) the House endorses the statement of the Speaker in relation to the constitutional questions raised by the Senate message in respect of this Bill:
- (2) the House, having regard to the public interest in the early enactment of the Bill, refrains from the determination of its constitutional rights in respect of the matter; and
