# 7 COMMONWEALTH ELECTORAL AMENDMENT BILL (NO. 1) 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Emerson, viz.—That all words after "That" be omitted with a view to substituting the following words: "the House is of the opinion that the bill should not be proceeded with, and:

- (1) calls on the Prime Minister to honour his promise to release the Tax Office audit report into the GST activities of the Queensland Division of the Liberal Party;
- (2) notes that the audit confirmed that the GST scam perpetrated in the Groom FEC was conducted more generally by the Liberal Party throughout other areas of Queensland;
- (3) notes that the Tax Office imposed a 50% penalty tax on the Queensland Division of the Liberal Party, indicating the falsehood of government claims that the GST scam was an 'error' or a 'mistake';
- (4) calls on the Treasurer to explain the details of the \$143,000 worth of sponsorships and internal Liberal Party transfers upon which GST was not paid when it should have been; and
- (5) calls on the Minister for Industry, Tourism and Resources to explain whether or not his FEC used the proceeds of the GST scam, which were in the FEC bank account as at August 2001, for his reelection campaign"—

Debate resumed.

Question—That the words proposed to be omitted stand part of the question—put.

"this House declines to give the Bill a second reading and:

- (1) condemns the government for:
  - (a) attempting to pre-empt a decision of the Full Court of the Federal Court of Australia concerning the issue of whether bargaining fees 'pertain to the relationship of employer and employee';
  - (b) introducing legislation which unreasonably restrains the ability of parties in the workplace to voluntarily enter into service agreements concerning industrial representation and advocacy; and
  - (c) introducing legislation which is primarily designed to discourage workplace organisation rather than to facilitate agreement-making; and
- (2) confirms that it is appropriate that the House await the decision of the Federal Court prior to legislating in this area".

The order of the day having been read for the second reading—Mr Slipper (Parliamentary Secretary to the Minister for Finance and Administration) moved—That the Bill be now read a second time—

Paper

Mr Slipper presented an explanatory memorandum to the Bill.

Debate, by leave, ensued.

Question—put and passed—Bill read a second time.

Leave granted for the question on the report to be put forthwith.

Question—That the Bill be reported to the House without amendment—put and passed.
