Bill read a first time.

### 4 MIGRATION LEGISLATION AMENDMENT (MIGRATION ADVICE INDUSTRY) BILL 2002

Bill read a first time.

Mr Hardgrave moved—That the Bill be now read a second time.

Debate adjourned (Mr Melham), and the resumption of the debate made an order of the day for the next sitting.

#### 5 VOCATIONAL EDUCATION AND TRAINING FUNDING AMENDMENT BILL 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Albanese, viz.—That all words after "That" be omitted with a view to substituting the following words: "whilst not seeking to deny the Bill a second reading, the House condemns the Government for:

- (1) failing to develop comprehensive transition strategies to assist young people, thereby abandoning at least 205,300 15 to 19 year olds, placing them at risk of not making a successful transition from school to work;
- (2) failing to keep its election promise to young people to provide a comprehensive response in the 2002 budget to the Youth Pathways Report;
- (3) failing to address youth unemployment, which is on the rise;
- (4) refusing to acknowledge the substantial adverse impact that the Government's Welfare Reform initiatives are having on TAFE;
- (5) failing to take a holistic approach to the needs of indigenous Australians resulting in a decline in participation in courses leading to a qualification; and
- (6) the Minister's double standards in espousing concern for the welfare of young Australians but failing to take any meaningful action to invest in their training needs; and

the House further notes that State and Territory Labor Governments have made significant achievements in the implementation of VET in schools while the Commonwealth has refused to provide growth funding, making the Labor States and Territories the leaders in this field"—

Debate resumed.

Question—That the words proposed to be omitted stand part of the question—put.

# 20 WORKPLACE RELATIONS AMENDMENT (GENUINE BARGAINING) BILL 2002—SENATE'S AMENDMENTS

The order of the day having been read for the consideration of the amendments made by the Senate—

On the motion of Mr Abbott (Minister for Employment and Workplace Relations), amendments (1), (2), (3), (6) and (7) were agreed to, after debate.

On the motion of Mr Abbott, amendments (4) and (5) were disagreed to, after debate.

Mr Abbott presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

# Senate Amendment (4)

Under section 170MW of the *Workplace Relations Act 1996*, a bargaining period can be suspended or terminated on the ground that the party which notified the bargaining period is not genuinely trying to reach agreement. The effect of Senate Amendment (4) would be to provide that genuinely trying to reach agreement includes 'bargaining in good faith'.

The Government does not support inclusion in the Workplace Relations Act of references to bargaining in good faith. The Act already provides protections against duress, coercion and discrimination in relation to bargaining. Beyond these protections, the bargaining process should be left to the immediate parties. The Australian Industrial Relations Commission should not be given a general role of scrutinising the approach to bargaining taken by the parties.

The House of Representatives does not accept this amendment.

#### Senate Amendment (5)

The effect of Senate Amendment (5), which is linked to Senate Amendment (4), would be to list in section 170MW of the Workplace Relations Act factors that the Commission would have to consider when assessing whether or not a party that is engaging in industrial action is bargaining in good faith. This amendment assumes that the parties should adopt a prescribed approach to bargaining – an approach which may not be appropriate or necessary in all circumstances. The House of Representatives does not support this approach, for the reasons given above.

The House of Representatives does not accept this amendment.

On the motion of Mr Abbott, the reasons were adopted.

# 23 MEDICAL INDEMNITY AGREEMENT (FINANCIAL ASSISTANCE—BINDING COMMONWEALTH OBLIGATIONS) BILL 2002

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr S. F. Smith who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words:

"while supporting the provisions of the Bill, the House:

- (1) condemns the Government for not adequately recognising the medical indemnity insurance problem and not acting quickly enough to address its adverse effects, including higher medical costs and reduced availability of services for Australians and their families;
- (2) recognises the ongoing problems in the general insurance, reinsurance and medical indemnity insurance industries and that confidence in those industries has been rocked by the collapse of HIH and the provisional liquidation of UMP/AMIL; and
- (3) calls on the Government to:
  - (a) assume a leadership role in the co-ordination of reforms necessary to State and Territory laws with the aim of uniformity in tort law reforms;
  - (b) consider putting in place a national scheme to ensure the long term care and rehabilitation needs of catastrophically injured Australians;
  - (c) ask the ACCC to ensure that whatever changes occur in medical indemnity insurance, no unfair or unreasonable oncosts flow to patients for the cost of their health care;
  - (d) play a more active role in bringing together medical defence organisations and representing them in negotiations with reinsurers;
  - (e) support APRA with appropriate resources to fulfil a greater regulatory role in medical indemnity insurance;
  - (f) require mandatory reporting of negligence claims and national data collection on health care negligence cases to help assess where major problem areas and issues lie;
  - (g) promote the enactment of national "open disclosure" legislation, including provision that an apology made as part of an open disclosure process is inadmissible in an action for medical negligence; and
  - (h) ensure that medical services provided by private hospitals, midwives, family planning clinics and aboriginal medical services are not disrupted due to a lack of appropriate and affordable insurance."
