Mr Williams presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate Amendment Number 1—Sunset Clause

This amendment would terminate the Bill three years after it receives Royal Assent.

The international and domestic security environment has changed forever and we cannot say for certain at what time, if any, the provisions of the Bill will no longer be necessary.

As the threat environment evolves, we will need to review the appropriateness of our tools in the fight against terrorism. The legislation will be reviewed by the Parliamentary Joint Committee on ASIO, ASIS and DSD three years after it commences. This will allow the new measures to be reconsidered without unnecessary and arbitrary time pressures.

Accordingly, the House of Representatives does not accept this amendment.

Senate Amendment Number 2-Definition of "terrorist act"

This amendment would insert a definition of "terrorist act" in the Bill.

It is not necessary to define the term "terrorist act" in the Bill. The relevant term in the Bill is "terrorism offence".

Accordingly, the House of Representatives does not accept this amendment.

Senate Amendment Numbers 8, 9, 12, 18, 19, 20, 21, 22, 25, 26, 33, 34, 42, 47 and 54—Questioning Regime

These amendments propose to establish a questioning regime in which the detention of persons to be questioned will not be available. The ability to detain people in strictly limited circumstances in order to gather relevant intelligence from them to prevent and deter terrorism is an essential element of the regime to be established by the Bill.

Accordingly, the House of Representatives does not accept these amendments.

Senate Amendment Numbers 16 and 17—Procedural Statement

These amendments would alter the regime for establishing a written statement of procedures governing the custody, detention and questioning of persons. They would have the effect of requiring that the written statement be made as a disallowable instrument. The statement of procedures is designed to be a detailed operational document. It is inappropriate to require it to be subject to disallowance by the Parliament. This would create unnecessary complexity and uncertainty.

Accordingly, the House of Representatives does not accept these amendments.

Senate Amendment Numbers 23 and 24—Prescribed Authority

These amendments would replace references to 'issuing authorities' with references to 'prescribed authorities'. This would have the effect that a prescribed authority would be required to perform functions in relation to the issuing of warrants. It is important to have a distinction between the functions of issuing warrants and presiding over questioning under warrants. This is best effected by maintaining two distinct roles: the issuing authority and the prescribed authority.

Accordingly, the House of Representatives does not accept these amendments.

Senate Amendment Numbers 27, 30, 32, 35, 36, 44, 45 and 46—Conduct of Questioning

These amendments would determine the conduct of questioning under a warrant, including restricting the time in which questioning can be conducted. This is inconsistent with the original purpose of the Bill which is to allow for the detention and questioning of persons for the collection of intelligence in relation to terrorism offences.

Accordingly, the House of Representatives does not accept these amendments.

Senate Amendment Numbers 28 and 55—Right to a Lawyer

These amendments would provide a person being questioned under a warrant with the ability to contact a lawyer of their choice at any time. They would also require the prescribed authority to advise the person being questioned of that right. The capacity to delay access to a lawyer for up to 48 hours is an essential element of the Bill. Further, it is also essential that there is an ability to security clear lawyers who would be present during questioning in advance. The amendments are therefore inconsistent with the policy of the Bill.

Accordingly, the House of Representatives does not accept these amendments.

Senate Amendment Number 37—Secrecy Provision

This amendment would impose secrecy obligations on persons questioned under a warrant and others. These obligations are expressed to exist indefinitely. It is inappropriate and unnecessary to fetter the ability of persons detained under a warrant to disclose that fact once the warrant has expired.

Accordingly, the House of Representatives does not accept this amendment.

Senate Amendment Numbers 10, 51, and 56-Children

These amendments would prevent a warrant being issued under the Bill in relation to persons between the ages of 14 and 18. They would also remove special rules governing the questioning of such persons and the conduct of their parents. It is essential that there be a capacity to question people between the ages of 14 and 18, subject to strict safeguards, for the purposes of gathering intelligence in relation to terrorism offences.

Accordingly, the House of Representatives does not accept these amendments.

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate Amendments 1—5

These amendments make a number of variations to a Bill which was drafted to implement a commitment made by the Commonwealth at the Ministerial Meeting on Public Liability Insurance on 30 May this year. At that meeting, the Commonwealth agreed to legislate to allow self assumption of risk for people who choose to participate in inherently risky activities, such as adventure tourism and sports. The Bill is designed to complement State and Territory initiatives directed to ensuring that outcomes in negligence actions reflect community expectations.

At the COAG meeting on Friday 6 December, COAG noted the Commonwealth's commitment to amend the Trade Practices Act to ensure that State and Territory legislation will not be compromised. Acceptance of the amendments would impose fetters on the capacity of parties to rely on the Bill, and hence would compromise the effectiveness of State and Territory reforms.

The House of Representatives therefore does not accept these amendments.

On the motion of Mr Slipper, the reasons were adopted.
