1 The House met, at 9 a.m., pursuant to adjournment. The Speaker (the Honourable Neil Andrew) took the Chair, and read Prayers.

2 SUSPENSION OF STANDING AND SESSIONAL ORDERS MOVED

Mr Rudd moved—That so much of the standing and sessional orders be suspended as would prevent the Minister for Foreign Affairs from making a full and comprehensive statement to the House to:

- (1) assure the Parliament that the Minister himself has not authorised the leaking of top secret, national security documents or information contained in them to unauthorised individuals;
- (2) assure the Parliament that the Minister has asked each of his ministerial staff whether they were responsible for the leaking of top secret national security documents or information contained in them;
- (3) assure the Parliament that the Minister has therefore assured himself and the Prime Minister that none of his ministerial staff have been responsible for the leaking of top secret national security documents or information contained in them;
- (4) provide these assurances to the Parliament prior to his departure later this morning from Parliament for Papua New Guinea;
- (5) advise the Parliament whether he or any member of his staff requested an additional copy of a classified national security document entitled *Iraq: Humanitarian Consequences* from the Office of National Assessments in the period immediately prior to 23 June 2003;
- (6) confirm to the Parliament the Minister's understanding that under the Ministerial Code of Conduct (section 5, page 10) that Ministers are required to be "honest in their public dealings and should not intentionally mislead the parliament and the public";
- (7) confirm that he has not intentionally misled the Parliament by not telling the complete truth in response to direct questions in the Parliament on this most serious matter of national security over the last week;
- (8) confirm the Minister's understanding that the leaking of top secret national security documents is a criminal offence under sections 70 and 77 of the *Crimes Act 1914* that carries the most serious penalties;
- (9) confirm the Minister's view on the acceptability or otherwise of the leaking of classified national security information for the purposes of undermining and destroying the professional credibility of private citizens who have publicly disagreed with government policy;
- (10) confirm that it is the Minister's understanding that under section 9 of the Ministerial Code of Conduct that Ministers are responsible for the conduct of their staff; and
- (11) confirm to the Parliament that given the gravity of the various breaches and offences involved in the leaking of top secret national security information that any involvement in such leaking by the Minister or his ministerial staff by definition requires resignation.

13 FAMILY ASSISTANCE LEGISLATION AMENDMENT (EXTENSION OF TIME LIMITS) BILL 2003

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr Swan, viz.*—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House:

- (1) condemns the Government's failure to comprehensively reform its flawed system of family assistance, which has so far resulted in one in three families receiving FTB and CCB accumulating debts in excess of \$1.2 billion;
- (2) urges the Government to immediately close loopholes such as share market margin lending losses and foreign income reporting which have allowed wealthy families to pocket benefits;

- (3) recognises the importance of annual tax returns for family budgeting and opposes the automatic stripping of family tax returns without warning to recoup family assistance debts;
- (4) notes the proposed two year time limit for past period claims of family assistance is still at odds with tax law which allows adjustments and subsequent claims to be made for up to four years; and
- (5) calls on the Government to reform family assistance to improve incentives to work and ensure benefits may properly account for changes in family income without the risk of families accruing an unavoidable debt"—
