The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Ms Gillard who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Government for:

- (1) failing to act to prevent the medical indemnity crisis and engaging in a series of political fixes not long term solutions to the medical indemnity crisis; and
- (2) allowing a health crisis to develop including medical indemnity and insurance arrangements".

Debate continued.

Amendment negatived.

- (3) a growing number of families who are financially squeezed and trying to balance work and family; and

(4) 500,000 Australians waiting up to five years to get their teeth fixed"—
