8 MILITARY REHABILITATION AND COMPENSATION (CONSEQUENTIAL AND TRANSITIONAL PROVISIONS) BILL 2003—SENATE'S REQUESTS

The order of the day having been read for the consideration of the amendments requested by the Senate—

On the motion of Mrs D. S. Vale (Minister for Veterans' Affairs), the requested amendments were made.

9 SUPERANNUATION SAFETY AMENDMENT BILL 2003—SENATE'S AMENDMENTS

The order of the day having been read for the consideration of the amendments made by the Senate— On the motion of Mr Cameron (Parliamentary Secretary to the Treasurer), amendments (1) to (25) and (28) to (39) were agreed to.

On the motion of Mr Cameron, amendments (26) and (27) were disagreed to, after debate.

Mr Cameron presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate Amendment 26

This amendment would require the Minister to grant financial assistance under Part 23 of the *Superannuation Industry (Supervision) Act 1993* (the SIS Act) equal to 100 per cent of an eligible loss (loss suffered as a result of fraudulent conduct or theft).

The House of Representatives notes that it is long-standing Government policy to cap financial assistance provided under Part 23 of the SIS Act at 90 per cent of the eligible loss. This cap assists to ameliorate the risks of moral hazard by providing incentives for superannuation fund members to monitor their retirement savings and to ensure that their fund is being managed in a prudent manner. Moreover, Part 23 of the SIS Act currently gives the Minister discretion to provide financial assistance up to 100 per cent of the determined eligible loss. The House of Representatives considers that legislative change to mandate 100 per cent financial assistance would inappropriately limit the Minister's ability to take into account public interest considerations when applying Government policy.

Accordingly, the House of Representatives opposes this amendment.

Senate Amendment 27

This amendment would require defined benefit funds (DBFs) to report annually to the Australian Prudential Regulation Authority (APRA) on their financial position, including the level of debt or surplus, and the details of any shortfall of funds required to pay benefits to members. Further, it would require APRA to publish DBF funding information on its website.

The House of Representatives considers that existing legislation and regulations appropriately provide for information on the financial position of DBFs to be reported to members, APRA and the public. The introduction of further reporting requirements would impose costs on both DBFs and APRA for minimal, if any, additional benefit. These costs would ultimately be borne by DBF members and the superannuation industry generally. They may also make DBFs less attractive to employer-sponsors.

Accordingly, the House of Representatives opposes this amendment.

On the motion of Mr Cameron, the reasons were adopted.
