8 TAX LAWS AMENDMENT (PERSONAL INCOME TAX REDUCTION) BILL 2004

Debate resumed by Mr Crean who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Government for:

- (1) failing to provide tax relief to 4 out of 5 taxpayers;
- (2) providing less in income tax cuts than it will collect in bracket creep in each of the years 2004-05, 2005-06, 2006-07 and 2007-08; and

(3) continuing to be the highest taxing government in Australia's history".
