Mr Truss (Minister for Agriculture, Fisheries and Forestry), pursuant to notice, presented a Bill for an Act to amend the *Australian Meat and Live-stock Industry Act 1997* and the *Export Control Act 1982*, and for related purposes.

Bill read a first time.

Mr Truss moved—That the Bill be now read a second time.

3 AGED CARE AMENDMENT BILL 2004

Ms J. I. Bishop (Minister for Ageing), pursuant to notice, presented a Bill for an Act to amend the *Aged Care Act 1997*, and for related purposes.

Bill read a first time.

Ms J. I. Bishop moved—That the Bill be now read a second time.

4 ABORIGINAL AND TORRES STRAIT ISLANDER COMMISSION AMENDMENT BILL 2004

The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—*And on the amendment moved thereto by Mr McMullan, viz.*—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House:

- (1) notes the failure of the Government's 'practical reconciliation' agenda;
- (2) condemns the Government for:
 - (a) failing to consult or negotiate with indigenous Australians on the provisions of the Bill;
 - (b) failing to explain how the proposed abolition of indigenous representative organisations and mainstreaming of indigenous programs from 1 July 2004 will address endemic Indigenous disadvantage;
 - (c) failing to develop a new legislative and administrative model that restores the right of indigenous Australians to be responsible for their own future; and

(3) notes Labor's support for the abolition of the Aboriginal and Torres Strait Islander Commission and creation of new legislative and administrative arrangements that restore responsibility and opportunity for indigenous Australians"—

Debate resumed.

Debate resumed by Mr Cox who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House condemns the Government for:

- (1) its failure to adopt the alternative approach of offering a superannuation tax cut to all contributors, as proposed by Labor; and
- (2) operating a system that fails to recognise the inability of low-income Australians to take advantage of measures to expand their superannuation while permitting spouses with wealthy partners to exploit the benefit".

Debate continued.
