2 SUSPENSION OF STANDING AND SESSIONAL ORDERS MOVED

Mr Emerson moved—That so much of the standing and sessional orders be suspended as would prevent the Minister for Small Business and Tourism from apologising to the House for repeatedly and deliberately misleading the House by:

- (1) claiming yesterday that the Member for Rankin had said in a press release that "In those cases where the small business is, in fact, insolvent, the redundancy obligations would be met through the Government's GEERS arrangements", while deliberately failing to complete the sentence which continued "and Labor's commitment to guarantee 100 per cent of employee entitlements";
- (2) falsely claiming on 27 May 2004 in relation to a COSBOA dinner that "everyone who was at the dinner who was paying attention to his words knows that the Member for Rankin uttered the words that he did not employ someone because of the unfair dismissal laws";
- (3) falsely claiming on 30 March 2004 that "Under the Labor Party's industrial relations policy, every employer has to give to an employee coming back from maternity leave an entitlement to part-time work rather than full-time work":
- (4) falsely claiming on 30 March 2004 that Labor has a policy to "push casual employees into permanent part-time employment";
- (5) falsely claiming on 23 March 2004 that Labor will introduce a national portable long service leave scheme; and
- (6) ignoring personal explanations and repeating these false claims in the House.

6 POSTAL SERVICES LEGISLATION AMENDMENT BILL 2003—SENATE'S AMENDMENTS

The order of the day having been read for the consideration of the amendments made by the Senate—

On the motion of Mr Williams (Minister for Communications, Information Technology and the Arts), amendments 1 to 5 and 10 to 12 were agreed to, after debate.

On the motion of Mr Williams, amendments 6 to 8 were disagreed to, after debate.

Mr Williams presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate amendments 6, 7 and 8

The proposed amendments give the Auditor-General additional powers to monitor and report to the Minister on specified matters relating to Australia Post's supply of services, instead of giving these powers to the Australian Communications Authority (ACA), as was proposed in the Bill as introduced into the Senate.

These amendments indicate support for some aspects of the ACA's monitoring role that were already contained in the Bill. They would have been unnecessary had the ACA's monitoring role, as proposed in the Bill, remained. Senate Amendments 6 and 7 are in identical terms to proposed provisions in the Bill. They provide that the prescribed performance standards to be met by Australia Post may relate to methods of determining the level of mail service in a particular area. They remove the requirement imposed on Australia Post to prepare a service improvement plan if the Minister considers it unnecessary in the circumstances. Senate Amendment 8 provides the Minister the power to request the Auditor-General to monitor and report to the Minister on specified matters relating to Australia Post's supply of postal services. It is in similar terms to proposed section 50E which provided for the Minister to direct the ACA to monitor and report to the Minister on specified matters relating to Australia Post's supply of postal services.

The Auditor-General is an agency whose principal function is that of auditing. It currently outsources its functions of monitoring Australia Post's performance against prescribed standards. The Auditor-General is not the appropriate body to conduct consumer quality of service monitoring.

Accordingly, the House of Representatives does not accept these amendments.

On the motion of Mr Williams, the reasons were adopted.

On the motion of Mr Williams, amendment 9 was disagreed to, and an amendment made in place thereof, after debate.

- (1) condemns the Government for its cynical election driven spending spree which—while spending a record \$52 billion over the forward estimates—failed to deliver crucial services to Australians, including:
 - (a) funding the pneumococcal vaccine for children;
 - (b) funding VET in schools so young Australians can either Earn or Learn;
 - (c) ensuring access to Higher Education without excessive fees or increasing student debt levels;
 - (d) ensuring all Australians can access bulkbilling services; and
 - (e) ensuring adequate measures to respond to Australia's skill shortage; and
- (2) also condemns the Government for failing to present a strategy to adequately address the long term fiscal challenges facing the nation"—
