Debate adjourned (Mr Truss—Minister for Agriculture, Fisheries and Forestry), and the resumption of the debate made an order of the day for a later hour this day.

10 MESSAGE FROM THE SENATE—TAX LAWS AMENDMENT (SUPERANNUATION REPORTING) BILL 2004

Message No. 32, 7 December 2004, from the Senate was reported returning the Tax Laws Amendment (Superannuation Reporting) Bill 2004 with amendments.

Ordered—That the amendments be considered immediately.

On the motion of Mr Brough (Minister for Revenue and Assistant Treasurer), the amendments were disagreed to, after debate.

Mr Brough presented reasons, which were circulated, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate amendments 1 and 2

The amendments moved in the Senate retain the employer reporting requirement and associated cost to business. The intent of the bill is to remove the reporting requirement.

Further amendments prescribing additional reporting requirements would mandate the development of an intrusive, expensive and unnecessary reporting system. The Australian Taxation Office's (ATO's) annual report already provides much of the information referred to in the amendments. This information is also published on the ATO website.

Accordingly, the House of Representatives does not accept these amendments.

On the motion of Mr Brough, the reasons were adopted.

11 NATIONAL SECURITY INFORMATION (CRIMINAL PROCEEDINGS) BILL 2004

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—

Debate resumed by Mr McClelland who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House calls upon the Government, consistent with the recommendations of the Australian Law Reform Commission, to:

- (1) implement a new Federal protected disclosure regime; and
- (2) include in the regime appropriate protection for persons working with security sensitive information and national security".

Debate continued.

- (5) refusing to provide any proper explanation of her role as Parliamentary Secretary in relation to the grant to A2 Milk Marketeers and her employment, in breach of the Ministerial Code of Conduct of Mr Ken Crooke, a person with a clear conflict of interest.

Ordered—That the amendments be considered immediately.

On the motion of Mr Brough (Minister for Revenue and Assistant Treasurer), the amendments were disagreed to, after debate.

Reasons of the House of Representatives for disagreeing to the amendments of the Senate

Senate Amendments 1 to 3

The House of Representatives does not support the amendments put forward in the Senate on two fronts:

First, the suggested amendments restate a rule that is already contained in the bill and that is the ability for the Aged Care Minister to make a determination that on the levels of care services required by residents are to be assessed.

Second, and more importantly, the amendments proposed will remove the requirement to assess whether residents require daily living assistance. If this amendment were carried it may require the ATO to assess eligibility of residents based on their individual needs. The ATO does not have the expertise to make such assessments and, in potentially having to issue rulings on this matter, would create the kind of uncertainty that this bill is designed to remove.

On the motion of Mr Brough, the reasons were adopted.
