2 THERAPEUTIC GOODS AMENDMENT BILL 2005

Mr Pyne (Parliamentary Secretary to the Minister for Health and Ageing), pursuant to notice, presented a bill for an Act to amend the *Therapeutic Goods Act 1989*, and for related purposes.

Bill read a first time.

Mr Pyne moved—That the bill be now read a second time.

3 SUSPENSION OF STANDING AND SESSIONAL ORDERS MOVED

Mr Andren moved—That so much of the standing and sessional orders be suspended as would prevent the Member for Calare from moving that this House:

- (1) condemns the Government for agreeing to the full sale of Telstra in the face of overwhelming public opposition;
- (2) notes the inability of the Government and Telstra to provide any credible figures on the amount needed to bring parity of price and parity of service to rural and regional Australia;
- (3) further notes the totally inadequate universal service obligation funding and the Government's continued ignoring of the Productivity Commission's 2001 inquiry into telecommunications regulation that supported the then Australian Communications Authority's belief that half a billion dollars per annum was needed to maintain and enhance the network;
- (4) calls on the Government to implement an immediate reinvestment strategy from existing income streams to ensure adequate telecommunications infrastructure and affordable services for all Australians wherever they live; and
- (5) calls on all country representatives to oppose the Telstra sale legislation.

4 WORKPLACE RELATIONS AMENDMENT (SMALL BUSINESS EMPLOYMENT PROTECTION) BILL 2004

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—And on the amendment moved thereto by Mr S. F. Smith, viz.—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House:

- (1) noting that the nation's independent umpire in industrial relations matters, the Australian Industrial Relations Commission (AIRC), has examined and heard submissions concerning the impact of redundancy payments on small business;
- (2) noting that the AIRC has found that the available evidence does not support the general proposition that small businesses across the board does not have the capacity to pay severance pay; but

(3) recognising the circumstances of those individual small business which are incapable of making redundancy payments;

calls on the Government to comply with the AIRC decision and to adopt mechanisms to address those individual businesses with a genuine incapacity to make redundancy payments"—

6 HEALTH INSURANCE AMENDMENT (MEDICAL SPECIALISTS) BILL 2005

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—

Debate resumed by Ms Gillard who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House condemns the Government for failing to:

- (1) address the medical workforce shortage affecting our rural, remote and outer metropolitan areas;
- (2) invest in the future of the medical workforce and its over reliance on importing skilled medical practitioners;
- (3) show leadership in the area of the uniform standards for medical professionals; and
- (4) address the impact that regulation of medical professionals by the colleges has on supply and distribution of specialists".

Debate continued.

7 SUPERANNUATION LEGISLATION AMENDMENT (SUPERANNUATION SAFETY AND OTHER MEASURES) BILL 2005

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—

Debate resumed by Mr Fitzgibbon who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House:

- (1) notes that Australian workers and their families are:
 - (a) not provided with full compensation in the event of theft and fraud from a superannuation fund; and
 - (b) not provided with compensation for the loss of statutory 9% Superannuation Guarantee (SG) contributions in the event of employer insolvency under the General Employee Entitlements Redundancy Scheme (GEERS); and
- (2) recognising that superannuation is compulsory, long term and for retirement, calls on the Government to:
 - (a) expand compensation for theft and fraud to 100% using the existing compensation mechanism;
 - (b) examine the inclusion for payment of unpaid Superannuation Guarantee (SG) payments within the GEERS scheme; and
 - (c) further consider a special provision for CSS members who applied for payments on CSS legal advice, later changed, to ensure payment is made for those who applied".

Debate continued.

Amendment negatived.
