The Speaker referred to the matter of privilege raised on 17 August 2005 by Mr Baldwin concerning an email and facsimile letter received by him from Mike Berwick, Mayor of Douglas Shire Council, which he considered constituted interference with his duties as a Member of the House.

The Speaker stated that in a previous case the Committee of Privileges recognised that there were competing interests in such cases and that this case raised similar issues of balance. On the one hand

Members should feel free to raise any matters they consider important to pursue. On the other hand, it is understandable that individuals will seek to defend their reputations against what they may see as inaccurate reflections.

After examining the correspondence provided by Mr Baldwin, the Speaker agreed that the warnings made in the letter were not desirable. However, on the information available to this point it was not clear that a prima facie case of contempt had been established. He further stated that if any additional material or similar approaches were made, he would be prepared to reconsider the issue.

 - (d) lead to the reduction in training and career opportunities for people who have chosen pharmacy as their career.
