# 5 MARITIME LEGISLATION AMENDMENT BILL 2005

- (b) failing to ensure adequate security in relation to the shipping of dangerous goods and hazardous material, including explosives precursors such as ammonium nitrate; and
- (c) failing to ensure ships comply with the requirement to provide details of crew and cargo fortyeight hours before arrival"—

Debate resumed.
