Ms Gillard moved—That so much of the standing and sessional orders be suspended as would prevent the Member for Lalor from moving—That the House notes that the Government has already restricted the rights of Members and the work of the Parliament:

- (1) by gagging debate on 14 bills in this sitting fortnight;
- (2) by destroying the Senate Committee system with its ability to investigate Government scandals like children overboard and to allow members of the public to participate in legislative processes; and
- (3) by doctoring Hansard to cover up mistakes by the Prime Minister;

and rejects this fourth heavy handed attempt described in order of the day No. 1 by the Government to restrict the rights of all Members to take part in debate on legislation and scrutinise the work of the Government.

6 LAW ENFORCEMENT INTEGRITY COMMISSIONER BILL 2006

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—

Debate resumed by Ms Roxon who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House:

(1) notes that it took the Howard Government almost seven years to commit to a policy of establishing a Law Enforcement Integrity Commissioner since the November 1996 Report 82 of the Australian Law Reform Commission entitled "Integrity: but not by trust alone. AFP & NCA complaints and disciplinary systems" first recommended a Federal independent anti-corruption commissioner;

- (2) notes that it has taken the Howard Government since June 2004 to bring actual legislation before the Parliament, creating a delay of almost ten long years in total;
- (3) notes that, despite the fact that the Australian Customs Service officers have:
 - (a) use of weapons including pistols and maritime deck mounted guns;
 - (b) powers of arrest and detention;
 - (c) powers of search and seizure;
 - (d) ability to conduct controlled operations;
 - (e) responsibility for collection of large amounts of border-related revenue;
 - (f) responsibility for storage of large amounts of contraband and dutiable goods like drugs, alcohol, tobacco, knives, guns and ammunition;

the Howard Government may have effectively exempted Customs from the oversight of the Law Enforcement Integrity Commission, by not specifically including it in the legislation;

- (4) notes that there are a range of other Commonwealth agencies with law enforcement style powers that should also receive oversight, such as the Department of Immigration, which under the Howard Government's maladministration wrongly held 26 Australians in Immigration detention; and
- (5) is opposed to the Government's proposed system of adding and subtracting agencies other than the AFP and ACC by regulation, noting such a system would effectively allow the Minister a veto over corruption investigations".

- (3) failure to properly upgrade security at regional airports; and
- (4) failure to establish adequate security measures for charter flights".

Question—put and passed—bill read a second time.

Leave granted for the question on the report to be put immediately.

Question—That the bill be reported to the House without amendment—put and passed.

4 COMMITMENT OF TROOPS TO EAST TIMOR—STATEMENTS BY THE PRIME MINISTER AND LEADER OF THE OPPOSITION—MOTION TO TAKE NOTE OF STATEMENTS—RESUMPTION OF DEBATE

The order of the day having been read for the resumption of the debate on the motion of Mr Beazley (Leader of the Opposition)—That the House take note of the statements—

Debate resumed.

Mr Price was granted leave to continue his speech when the debate is resumed.

Debate adjourned, and the resumption of the debate made an order of the day for the next sitting.
