1 The House met at 2.50 p.m. The Speaker (the Honourable David Hawker) took the Chair, and read Prayers.

#### 2 GARUDA 737 CRASH, YOGYAKARTA

Mr Howard (Prime Minister) moved—That the House:

- (a) record its deep regret at the tragic loss of life and serious injuries that resulted from the aircraft accident in Yogyakarta, Indonesia, on 7 March 2007;
- (b) note that amongst the 21 people killed were 5 Australians serving their nation, working for:
  - the Australian Federal Police—Mark Scott and Brice Steele;
  - the Department of Foreign Affairs and Trade—Liz O'Neill;
  - AusAid—Alison Sudradjat; and
  - the Fairfax press-Morgan Mellish; and
  - record its deep appreciation of their meritorious public service;
- (c) tender its profound sympathy to the Government and people of Indonesia, and to the families of all the people killed and injured in the accident; and
- (d) extend its best wishes to all those injured for a speedy recovery, recalling particularly Cynthia Banham, Michael Hatton, Kyle Quinlan and Roger Tallboys.

Mr Rudd (Leader of the Opposition) having seconded the motion, Mr M. A. J. Vaile (Leader of the Nationals) and Ms Gillard (Deputy Leader of the Opposition) and other Members having addressed the House in support thereof, and all Members present having risen in their places as a mark of respect—

Debate adjourned (Mr Abbott—Leader of the House), and the resumption of the debate made an order of the day for the next sitting.
