- (1) finds Ms Harriett Swift guilty of a contempt of the House in that she undertook conduct that amounted to an improper interference with the free performance by the Member for Eden-Monaro of his duties as a member; and
- (2) reprimands Ms Swift for her conduct.

On the motion of Mr Pearce (Parliamentary Secretary to the Treasurer), the bill was read a third time.

Question—put and passed—bill read a second time.

Leave granted for third reading to be moved immediately.

On the motion of Mr Pearce (Parliamentary Secretary to the Treasurer), the bill was read a third time.

# 14 FAMILIES, COMMUNITY SERVICES AND INDIGENOUS AFFAIRS LEGISLATION AMENDMENT (CHILD CARE AND OTHER 2007 BUDGET MEASURES) BILL 2007

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—

Debate resumed by Ms Macklin who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House notes that:

- (1) child care out of pocket costs are increasing five times faster than average prices for all goods and services;
- (2) for the past four years, child care out of pocket costs have increased by more than 12 per cent each year:
- (3) on average families will receive \$813 from the changes to the child care tax rebate, not \$8000 as the Government claimed;
- (4) many parents continue to experience difficulties accessing appropriate child care for their children;
- (5) high quality child care must be assured by a rigorous accreditation process focused on quality improvement;
- (6) despite the international consensus on the benefits of early childhood education, Australia ranks last in the OECD on the percentage of GDP spent on pre-primary education; and
- (7) there are currently 100,000 four years olds in Australia that do not attend preschool".

Debate continued.

Amendment negatived.

Question—That the bill be now read a second time—put and passed—bill read a second time.

Message from the Governor-General

Message No. 303, 5 June 2007, from His Excellency the Governor-General was announced recommending an appropriation for the purposes of the bill.

Leave granted for third reading to be moved immediately.

On the motion of Mr Brough (Minister for Families, Community Services and Indigenous Affairs), the bill was read a third time.

# 15 MIGRATION (SPONSORSHIP FEES) BILL 2007

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—

Debate resumed.

Question—put and passed—bill read a second time.

Leave granted for third reading to be moved immediately.

On the motion of Mr Farmer (Parliamentary Secretary to the Minister for Education, Science and Training), the bill was read a third time.

# 16 SOCIAL SECURITY AMENDMENT (APPRENTICESHIP WAGE TOP-UP FOR AUSTRALIAN APPRENTICES) BILL 2007

The order of the day having been read for the resumption of the debate on the question—That the bill be now read a second time—And on the amendment moved thereto by Mr S. F. Smith, viz.—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the bill a second reading, the House welcomes additional financial support for first and second year apprentices but condemns the Government's complacency and neglect of vocational education and training over the past 11 long years seen through:

- (1) the Government slashing its investment in vocational education and training by 13 per cent in the three years to 2000;
- (2) between 2000 and 2004, increasing this investment by only 1 per cent;
- (3) the failure of the Government to address the acute shortages of skilled labour across Australia, which the Government itself estimates to be a shortfall of 240,000 skilled workers by 2016;
- (4) the cynical political response to the national skills crisis of a standalone network of Australian Technical Colleges that will only produce 10,000 graduates by 2010; and
- (5) the failure of the Government to address apprenticeship completion rates, with almost 50 per cent of apprentices cancelling or withdrawing from training each year while Labor has been calling since 2005 for \$2000 payments to encourage completion of traditional trade apprenticeships"—

Debate resumed.

It being 2 p.m., the debate was interrupted in accordance with standing order 97, and the resumption of the debate made an order of the day for a later hour this day.

Member directed to leave

At 2.22 p.m. the Member for Lilley (Mr Swan) was directed, under standing order 94, to leave the Chamber for one hour for continuing to interject after a warning had been given from the Chair, and he accordingly left the Chamber.

Suspension of standing and sessional orders moved

Mr Rudd (Leader of the Opposition) moved—That so much of the standing and sessional orders be suspended as would prevent the Leader of the Opposition moving immediately—That this House censures the Prime Minister for:

- (1) misusing the official residences for party political fundraisers in breach of the Prime Minister's own "Guide on Key Elements of Ministerial Responsibility";
- (2) misleading the House about the misuse of these official residences;
- (3) placing the Commonwealth in a position of non-compliance with the Commonwealth Electoral Act by making a "gift" of the use of the official residences to the Liberal Party of Australia; and
- (4) undermining the independence of the Australian Electoral Commission.

Debate ensued.

Question—That the motion for the suspension of standing and sessional orders be agreed to—put.

Proposed expenditures—

Health and Ageing Portfolio, \$4,914,078,000—debated and agreed to.

Foreign Affairs and Trade Portfolio, \$4,180,814,000—debated and agreed to.

Ordered—That the order for consideration of the proposed expenditures agreed to on Tuesday, 12 June 2007 by the Main Committee be varied by next considering the proposed expenditure for the Treasury Portfolio and then the Defence (Veterans' Affairs) Portfolio, the Prime Minister and Cabinet Portfolio, the Attorney-General's Portfolio, and the Finance and Administration Portfolio.

Treasury Portfolio, \$3,688,304,000—debated and agreed to.

Defence Portfolio, \$19,720,501,000—further debated and agreed to.
