The greater the policy issues and the more difficult the decisions, the more likely it is that mistakes will be made, and parliamentary scrutiny and control is essential to disclose and remedy those mistakes. Government itself is weakened by lack of accountability. The Senate and its processes provide a large part of the scrutiny that will be required. The means by which it may do so are here recorded.” (from the preface)

- the role of the Senate in Australia's bicameral federal system
- parliamentary privileges, powers and immunities, including inquiry powers
- the legislative process, including hearings on bills by committees
- the protection of civil liberties through the scrutiny of bills and delegated legislation
- elections, the filling of vacancies, qualifications and disqualifications
- conduct of proceedings, motions, amendments, debate, question time etc
- Senate committees and the rights of witnesses who appear before them
- relations with the executive government and claims of public interest immunity
- relations with courts and the judiciary
- relations between the two Houses of Parliament, disagreements and simultaneous dissolutions.
