## Question

**Senator Pratt:** "...in the consultations from the last few years, what is still outstanding and sits more unresolved through those consultations."

## **Answer**

From time to time, ASX will conduct a public consultation on specific market matters. The details of these consultations can be found on ASX's website within the Public consultations tab.

Since 1 January 2021, ASX has conducted nineteen public consultations, of which two are outstanding.

ASX has publicly released response papers summarising consultation feedback and outlining ASX's proposed approach in relation to eleven consultations. There are three consultation where ASX has effected the proposed changes without publicly releasing a response paper. In relation to a further three consultations, ASX expects to respond by the end of the current calendar year.

There are two consultations where ASX can be considered to have an outcome that is not fully resolved. The response to the consultation titled *Proposed enhancements to the ASX Listing Rules: Continually improving the reputation and integrity of the ASX market*, is still in progress with final completion taking longer than anticipated.

The consultation titled *Proposed ASX rule amendments to facilitate the listing of CCIVs and certain other collective investment vehicles on the ASX market and the quotation of their products on the ASX AQUA market,* is currently on hold.
