Procedures for dealing with witnesses

On 13 November 2013 the House agreed to a resolution on *Procedures for dealing with witnesses* (VP 2013–14/58–9). This resolution adopted the provisions referred to throughout this chapter as being recommended by the Procedure Committee (with minor changes in wording). The resolution is reproduced in full as an attachment to the Standing Orders.

Appointment of Chair and Deputy Chair (pp. 660–61, 663)

On 13/11/2013 standing order 232 was amended to provide that Chairs of House committees are to be appointed by the Prime Minister and Deputy Chairs by the Leader of the Opposition.

Oral reports (p. 711)

New S.O. 143(c) adopted 13/11/2013:

If, having considered a bill referred to it for an advisory report, a committee finds no issues requiring a formal report, a statement to the House by the Chair or Deputy Chair to that effect, together with the presentation of the relevant minutes of proceedings, discharges the committee's obligation to report on the bill.

Video and teleconferencing (p. 723)

S.O. 235(b) was amended on 13/11/2013 to read:

A committee may conduct proceedings using audio visual or audio links . . (instead of 'A committee may resolve to conduct . . ')
