

QW49: In the above example, what is the additional cost of regulatory capital that is incurred by the bank arising from the customer failure to make the payment on time?

Answer: Westpac has never undertaken the kind of detailed analysis that would allow us to quantify with precision the cost of holding additional regulatory capital in respect of any particular credit card late payment event by an individual customer.
