Minor Treaty Actions

Minor treaty actions (formerly referred to as 'Category 3' treaty actions) are identifiably minor treaty actions (mainly minor/technical amendments to existing treaties) which do not impact significantly on the national interest. Minor treaty actions are tabled with a one-page explanatory statement. The Treaties Committee has the discretion to formally inquire into these treaty actions or indicate its acceptance of them without a formal inquiry and report.
