2 Fit-out of new leased premises for the Australian Federal Police at 45 Commercial Road, Newstead, Queensland

Recommendation 1

The Committee recommends that the House of Representatives resolve, pursuant to Section 18(7) of the *Public Works Committee Act 1969*, that it is expedient to carry out the following proposed work: Fit-out of new leased premises for the Australian Federal Police at 45 Commercial Road, Newstead, Queensland.

Recommendation 2

The Committee requires that the Australian Federal Police review and amend as necessary its public works procurement processes to ensure early identification and assessment of security requirements. The review should include consideration of site selection processes to ensure that it is not unnecessarily constrained.

Recommendation 3

The Committee requires that the Australian Federal Police provide it with an update on the occupational capacity reached in the final design specifications for new leased premises at 45 Commercial Road, Newstead. This update should be provided as soon as the information is available
