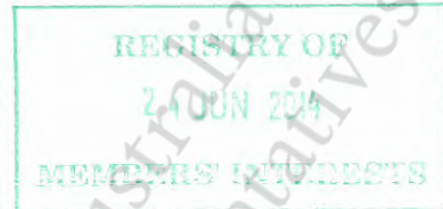

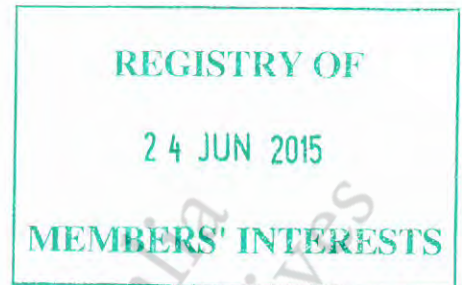

RE: MEMBERS' INTERESTS - FOXTEL SUBSCRIPTION

On Thursday 4 June 2015, my Office Manager made contact with the Department of Finance, Entitlements Branch regarding a Foxtel service currently installed in my Electorate Office. The Entitlements Branch advised they were not responsible for the service.
