

Bills

114.01 Amendment moved to second reading amendment; fewer than five Members vote on one side

On Wednesday 26 February, during resumption of debate on the Primary Industries (Excise) Levies Amendment (Dairy Produce) Bill 2014, a non-aligned Member moved an amendment to a second reading amendment which had been moved by an Opposition Member. When the question on the amendment to the second reading amendment was put, a division was called and the only Members on the side of the ayes were three non-aligned Members. There being fewer than five Members on one side, the Chair declared the question resolved in the negative without completing the count and the names of those in the minority were recorded in the Votes and Proceedings.

114.02 Proceedings on the Qantas Sale Amendment Bill 2014

During Government business time on Thursday 6 March, the Minister for Infrastructure and Regional Development, pursuant to notice, presented the Qantas Sale Amendment Bill 2014. The bill was read a first time and the Minister moved the second reading and made a second reading speech. The Speaker called on an Opposition Member to move that debate be adjourned. The Manager of Opposition Business then sought leave to move that the second reading debate proceed immediately. Leave was not granted.

The Manager of Opposition Business then moved to suspend standing orders to enable the second reading debate on the bill to proceed immediately and was closured on division. The Shadow Minister for Infrastructure and Regional Development seconded the motion and, while he was addressing the motion, the Leader of the House moved a closure of Member. A division was called, during which the Leader of the House indicated that the Government would support the suspension of standing orders and the withdrawal of the division. The division was not proceeded with and debate resumed on the suspension motion. The question on the suspension motion was put and carried on the voices.

Debate then resumed on the second reading of the bill and after a number of speakers, the Leader of the House moved a closure of question, which was agreed to on division. The second reading was then agreed to on division.

The Minister for Infrastructure and Regional Development sought leave to move the third reading immediately; leave was not granted. The bill was then considered in detail. Leave was granted for the bill to be considered as a whole and debate ensued on the question that the bill be agreed to. As the Shadow Minister for Infrastructure and Regional Development was speaking to the motion, the Leader of the House moved a closure of question, which was agreed to on division. The bill was then agreed to on division.

The Leader of the House sought leave to move the third reading immediately, which was not granted. He then, pursuant to contingent notice, moved that so much of standing orders be suspended as would enable the third reading to be moved immediately. Debate ensued and the Leader of the Opposition was closured on division. As the Shadow Minister for Infrastructure and Regional Development was speaking to the suspension motion, the Leader of the House moved that the question be put, which was agreed to on division. The question on the suspension motion was then agreed to on division.

The Minister for Infrastructure and Regional Development moved the third reading and debate ensued. The Leader of the House moved that the question be put which was agreed to on division. The question on the third reading was then agreed to on division and the bill was read a third time.

Privilege

The Leader of the House then moved that the matter of whether ... the former Member for Dobell had deliberately misled the House be referred to the Committee of Privileges and Members' Interests.
